Dear Secretary Walther,

I respectfully request your approval for additional appropriation under Section 33 of Act 997 of 2021, in the amount of \$2,000,000 to the NCRC Grant and Trust Fund for the Department of Parks, Heritage and Tourism – Natural & Cultural Resources Council. The Arkansas Natural and Cultural Resources Council (ANCRC) was established by the Arkansas Legislature in 1987 by Arkansas Act 729 to manage and supervise a grant and trust fund for the acquisition, management, and stewardship of state-owned properties acquired or used for ANCRC approved purposes. The grants are funded through a percentage of collections in the state's real estate transfer tax.

Applicants eligible for funding from the Natural and Cultural Resources Grants and Trust Fund are agencies of the State of Arkansas receiving General Revenue funding and are authorized by law to acquire, manage, operate or maintain state-owned lands or to preserve state-owned historic sites, buildings, structures or objects which the Council determines to be of value for recreation or conservation purposes.

Federal matching grant dollars have become available for reimbursement of successful ANCRC-funded projects and will be received in early FY22. This appropriation increase is necessary to allow the department to take advantage of this reimbursement and disburse these funds as determined by the bylaws of the council.

The department is requesting an increase of \$2,000,000 in Commitment Item 04, Grants and Aid, Fund TGT0100, Fund Center 480, and Business Area 0887.
