The Arkansas Securities Department (ASD), a division of the Arkansas Department of Commerce, maintains a bank account with Simmons Bank for the purpose of depositing money for licenses and fees collected from the Securities Industry. Once the fees are processed and the determination has been made as to how much is general and special revenue the funds are transferred to the state treasury.
