Dear Mr. Walther:

We respectfully request \$2,000 in FY22 temporary appropriation holding fund for the Military Funeral Honors Fund. This appropriation is utilized to pay for a stipend for the cost of providing military funeral honors at veterans' funerals and the volume of stipend requests will fluctuate.

We respectfully request \$175,000 in FY22 temporary appropriation holding fund for the Veterans' Cemetery State Fund. This appropriation is utilized to pay for operating costs of the cemetery which include maintaining cemetery grounds, utilities, and routine repairs and maintenance.

Income Certification

Funding for the Military Funeral Honors Fund is provided from military license plates and the treasury cash balance is \$302,879.91 as of October 7, 2021. Funding for the Veterans' Cemetery State Fund is provided from the agency's general revenue allocation and salary savings for this fiscal year.
