

# DHS REALLOCATION OF RESOURCES REQUEST #3 OF 4 FY2022 March PEER

This is the third request by the Department of Human Services for Reallocation of Resources, from a limit of four annually. Section 11(c) of Act 457 of 2021 allows transfer authority to DHS and sets limits for the number of requests, dollar amounts of the total requests, and the purpose for which requests can be submitted.

This set of requests reflects the following impact to the allowances found in Section 11(c):

The following paragraphs outline the need for the transfers as requested by Division.

## SECRETARY'S OFFICE

The Secretary's Office (SO) is requesting to transfer 2 positions from the Division of Medical Services to serve within the division's Office of Information Technology.

The Secretary's Office is requesting to transfer \$365,000 from Professional Fees to Capital Outlay within their Operations appropriation to cover equipment purchases for their IT department and print shop.

### DIVISION OF AGING, ADULT, AND BEHAVIORAL HEALTH SERVICES

The Division of Aging, Adult, and Behavioral Health Services (DAABH) is requesting to transfer 6 positions from various divisions to better align with the divisions needs for various leadership roles:

- 4 positions from the Secretary's Office
- 1 position from the Division of Medical Services; and
- 1 position from the Division of Provider Services and Quality Assurance.

The division is also requesting to transfer \$3,150,000 from their Alcohol and Drug Abuse Prevention appropriation to various appropriations within the division as follows:

- \$30,000 to the Older Worker Program;
- \$370,000 to the Nursing Home Care Alternatives;
- \$1,000,000 to State Operations for Regular Salaries;
- \$1,000,000 to State Operations for Personal Services Matching; and

- \$750,000 to State Operations for Overtime.

These transfers are necessary for Salary, Personal Services Matching and Overtime Expenses for the Arkansas State Hospital and Arkansas Health Center. DAABH also needs to transfer for the Area Agencies on Aging for the State Older Worker Program and the State Aging Services.

### DIVISON OF CHILD CARE AND EARLY CHILDHOOD EDUCATION

The Division of Child Care and Early Childhood Education (DCCECE) is requesting to transfer \$500,000 from Professional Fees to their Operating Expense line within their Operations appropriation for the purchase of IT software and hardware.

## DIVISION OF CHILDREN AND FAMILY SERVICES

The Division of Children and Family Services (DCFS) is requesting to transfer \$7,000,000 from State Foster Care and \$2,000,000 from State Residential Treatment for a total appropriation transfer of \$9,000,000 to better align for cost allocation purposes. The transfers are detailed below:

- \$4,500,000 to TANF/Foster Care
- \$4,000,000 to Professional Fees & Services
- \$500,000 to Personal Services Matching

## DIVISION OF COUNTY OPERATIONS

The Division of County Operations (DCO) is requesting to transfer 25 positions from various divisions to better serve the Long-Term Services and Support Unit:

- 13 positions from the Secretary's Office;
- 4 positions from the Division of Aging, Adult, and Behavioral Health Services;
- 1 position from the Division of Child Care and Early Childhood Education;
- 3 positions from the Division of Developmental Disabilities;
- 2 positions from the Division of Medical Services;
- 1 position from the Division of Provider Services and Quality Assurance; and
- 1 position from the Division of Youth Services.

The division is also requesting to transfer a total of \$613,014 for their Regular Salaries appropriation.

- \$500,000 from the Secretary's Office Regular Salaries to provide for the salary expenditures the division will incur; and
- \$113,014 from the Division of Aging, Adult, and Behavioral Health Services Regular Salaries to provide salary support for the two registered nurse positions transferred from the division.

Additionally, the division is requesting to transfer a total of \$525,959 for their Personal Services Matching appropriation.

- \$500,000 from the division's Extra Help line item; and
- \$25,959 from the Division of Aging, Adult, and Behavioral Health Services to provide matching appropriation for the two registered nurse positions transferred from the division.

## DIVISION OF DEVELOPMENTAL DISABILITIES

The Division of Developmental Disabilities (DDS) is requesting to transfer 10 positions from the Division of County Operations to assist with direct client care at the Human Development Centers.

The division is also requesting to transfer a total of \$990,000 from their Regular Salaries appropriation.

- \$690,000 to Overtime within their Operations appropriation to assist with overtime expenses related to direct care staff at the Human Development Centers.
- \$300,000 to Data Processing Services within their Operations appropriation to cover an increase in their annual software licensing and claims processing expenses.

## DIVISION OF MEDICAL SERVICES

The Division of Medical Services (DMS) is requesting to transfer 2 positions from the Secretary's Office to serve as the Assistant Director of Administration and Operations, and for the Prior Authorization Utilization Review unit to assist with procedure code linking tables.

## DIVISION OF PROVIDER SERVICES AND QUALITY ASSURANCE

The Division of Provider Services and Quality Assurance (DPSQA) is requesting to transfer 4 positions from various divisions to better serve clients needs and services, specifically the Survey and Certification clients:

- 3 positions from the Division of Aging, Adult, and Behavioral Health Services; and
- 1 position from the Division of County Operations.
