Justification;
Donor Division (From Transfers):
Recipient Oivision ( To Transfers):
The Division of County Operations requests to redirect unbudgeted appropriation from the Transitional Employment Assistance (TEA) Program to other budget line items which have insufficient appropriation. One of these line items is Character 11 Capital Outlay which needs \$170,000 to cover the purchase of a new refrigerated bob truck in the Commodities Distribution Program. This purchase will be made with 100% Federal funds allocated for food distribution costs.
The second budget tern needing elditional appropriation in SFY 2016 to the Salvage and Container (SAC) Fund. A total of \$118,300 in additional appropriation is needed in the SAC Fund 02 Operating Expenses line item to allow the agency to utilize reimbursements for the cost of demograd bod products in the Commodities Distribution program. These funds will be reinvested in the Commodities program to help pay for the storage and distribution of food commodities.
The third budget item with insufficient approprietion in SFY 2015 is the Community Services Block Grant (CSBG) Program. An additional \$160,898 is being requested in this budget to allow the agency to utilize additional funds in the CSBG Program.
