Attorney General Quarterly Report Pursuant to ACT 763 of 2013

<u>Case Name of Court Order or Settlement Agreement and the amount of funds received by the Office of</u> the Attorney General for each Court order or Settlement Agreement during the third quarter:

Grouschow - \$ 12,600.00 recovered this quarter in connection with a settlement to redress discrimination on the basis of race or national origin in the rental of an apartment. The funds were distributed to four separate people/entities that were represented in the settlement.

AmeraCard Enterprise - \$1,500.00 recovered this quarter in settlement of a case against a seller of fake ID cards. The judgement was drafted by the Attorney General's Office and was submitted to the Court for review and approval.

Tmobile USA, Inc. – \$230,550.9S recovered this quarter in connection with a settlement of a mobile cramming investigation. Counsel for the multistate investigatory group and the Attorney General's office negotiated and jointly drafted this agreement with opposing counsel.

Standards & Poor's - \$21,S35,714.00 recovered this quarter. Counsel for the Attorney General's office worked with other State Attorneys General and opposing counsel to jointly draft an agreement to resolve allegations that S&P misled investors when it rated structured financial securities.

eBooks - \$57,353.75 was recovered this quarter. Counsel for the Attorney General's office worked with other State Attorneys General and opposing counsel to jointly draft an agreement to resolve allegations that eBooks misled investors when it rated structured financial securities.

Sirius XM - \$60,178.14 recovered this quarter from the claims administration connection with a case regarding auto-enrollment without authorization. Counsel for the multistate investigatory group and the Attorney General's office negotiated and jointly drafted this agreement with opposing counsel.
