Buy Right, Inc. and Haitham Katoom - Retail tobacco store found with a small amount of unapproved cigarettes. Negotiated an Assurance of Voluntary Compliance (AVC) with Buy Right, Inc., and these are payments to Consumer Education &

## Grand River Enterprises:

State of Arkansas v. Grand River Enterprises — Counsel for the Attorney General worked with Grand River to obtain a settlement agreement for noncompliance with Arkansas's tobacco statutes.

#### Tri-State Pawn of Texarkana:

State of Arkansas v. Tri-State Pawn of Texarkana — Counsel for the Attorney General worked with Tri-State Pawn's counsel to obtain a consent judgment resolving Tri-State Pawn's unconsionable business practices

#### Harvey C. Couch:

Higdon Ferry Superstop, LLC and Harvey Couch - Retail tobacco store found with small amount of unapproved cigarettes. Negotiated an AVC with Harvey Couch, and these payments to consumer education and enforcement.

#### Johnson & Johnson:

Johnson & Johnson Multi-State Investigation - With 42 other states, counsel for the Attorney General worked with Johnson & Johnson to obtain a settlement agreement in resolution of the states' investigation into Johnson & Johnson's violation of consumer protection laws by delivering for introduction into state markets certain batches of over-the-counter drugs that failed to comply with federal standards.

## Target Corporation:

Target Corporation Multi-State Investigation - With 46 other states, counsel for the Attorney General worked with Target to obtain a settlement in resolution of the states' investigation into Target's 2013 data breach.

## United Networks of America:

State of Arkansas v. United Networks of America - Counsel for the Attorney General worked with United Networks of America to obtain a settlement for multiple violations of consumer protection laws, including status governing health-related cash discount cards.

#### Yolanda Hartin:

State of Arkansas v. Yovana Hartin dba Orientacion Latina - Counsel for the Attorney General worked with Yovana Hartin's counsel to obtain a consent judgement resolving Yovana Hartin's unconscionable business practices
