This position is requested due to the creation of the College of Veterinary Medicine at ASUJ and to meet this national shortage and the demand for veterinarians within the State of Arkansas. This is a new title.

The Dean of Veterinary Medicine will serve as the chief administrative officer for the College of Veterinary Medicine and will be responsible for the accomplishment of teaching, research, and service missions. He/she will oversee all academic programs associated with the Veterinary Medicine Program. The Dean of Veterinary Medicine will manage the budget and resources. In addition, they will oversee the recruiting, hiring, supervising, and evaluation of personnel within the college. Additionally, the Dean of Veterinary Medicine will work with the faculty and staff in establishing and implementing the mission and strategic plan. He/she will serve as the primary spokesperson for the college and ensure compliance with all requirements of the college and university accrediting bodies. In addition, Dean of Veterinary Medicine will oversee and participate in major fundraising initiatives and activities of the college.
