Re: Arkansas Supreme Court Appropriation Request, FY 2017

Gentlemen:

This morning the Joint Budget Committee referred a letter from me dated March 31, 2016, to your committee for your review and recommendation. Since the time of my original letter, the Arkansas Supreme Court received and approved an additional request which requires a revision to our initial request. Please substitute this letter as the full explanation of our request for an amendment to Senate Bill 69.

This revised request includes four revisions to the FY2017 appropriation for the Arkansas Supreme Court being considered during the Fiscal Session of the Arkansas General Assembly. None of these requests require a change to any of the agency's funding or appropriation levels.

The first change is within Section 5 of SB69, which contains the positions which are paid through the Bar of Arkansas account. These employees are paid with cash funds which are generated as a result of the Supreme Court's management and oversight of the practice of law pursuant to Amendment 28 of the Arkansas Constitution. One of these programs, the Judges and Lawyers Assistance Program, provides counseling and related services to Arkansas

judges, attorneys and law students who are impaired due to issues of drug and alcohol addiction. The current staff consists of two licensed therapists. Due to an increase in the need for their services, the JLAP program needs clerical and office assistance to support its work. We need to add an additional position to this section of the appropriation as follows:

SUPREME COURT ADMIN ASSISTANT JLAP

GRADE 115

The second change—also within Section 5 of SB69 and part of the Bar of Arkansas account—will add a Program Coordinator position to the Arkansas Access to Justice Commission. The Commission coordinates statewide efforts to ensure that all Arkansans have equal access to the civil justice system. The Commission's two staff oversee the work of the Commission, as well as the court's Interest on Lawyer Trust Accounts (IOLTA) program. Additional capacity is needed for the Commission to implement initiatives designed to make legal representation more affordable for and accessible to the Arkansans who need them, including Arkansans in rural and underserved areas of the state. We need to add another position to this section of the appropriation as follows:

SUPREME COURT PROGRAM COORDINATOR OF AJC GRADE 126

No increases in the appropriation levels to support these additional positions are necessary.

The third change—also within Section 5 of SB69 and part of the Bar of Arkansas Account—will add a staff attorney position for the Committee on Professional Conduct. The work of the Committee is essential to ensure the proper discipline of attorneys who violate ethical standards. We need to increase from one to two of the following positions within Section 5 as follows:

SUPREME COURT STAFF ATTORNEY OPC

GRADE 126

No increase in the appropriation levels to support the position is necessary.

The final change involves an upgrade to a current position found in Section 1 of SB96 and is a result of a revision of job duties and responsibilities which has already taken place. The position, "CODE Q123C ADMINISTRATIVE ASSISTANT" is a grade C115 and has previously functioned as clerical support. With recent changes to utilize technology to automate our processing of claims, we have increased the responsibilities of the position and the level of training and expertise required. The position now interacts directly with and functions consistent with the duties of other employees within the Office of the Clerk. We would, therefore, request that the position be re-titled as "Deputy Clerk" and re-classified from a Grade C115 to a Grade C117.

No increase in the appropriation levels to support the increase in grade are necessary.

I respectfully request your review and approval of these four changes during the Fiscal Session. Should you have a question or require further information, feel free to let me know.
