Please amend SECTION 1. REGULAR SALARIES as follows and renumber item No.s accordingly:

This position will be utilized to hire a Program Administrator for the Crimes Against Children Program, who will be responsible for the CACD Investigators and Hotline Operations. The agency is surrendering one position to offset the added position.

Please amend SECTION 3 - APPROPRIATION - OPERATIONS, as follows:

Please delete SECTION's 15 and 16 of SPECIAL LANGUAGE in their entirety. The need for this language has been eliminated due to the new section of appropriation being added for Confiscated Funds Transfer.

Please delete SECTION 17. SPECIAL LANGUAGE. MOTOR VEHICLE
PURCHASES/RENOVATION., in its entirety. This language is unnecessary as General Revenue funding has not been allocated to the Motor Vehicle Acquisition Revolving Fund since 2005.

Please delete SECTION 19. SPECIAL LANGUAGE. MOTOR VEHICLE PURCHASE, in its entirety and substitute the following:

SECTION 19. SPECIAL LANGUAGE NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MOTOR VEHICLE PURCHASE. The Department of Arkansas State Police is hereby authorized to purchase motor vehicles from the appropriations authorized for Capital Outlay in the State Police Operations and/or Confiscated Funds Transfer appropriation in this Act. Motor vehicles donated to Arkansas State Police and confiscated vehicles used for Arkansas State Police operations shall not be included in the maximum number of authorized passenger vehicles.

The provisions of this section shall be in effect only from July 1,2017 through June 30, 2018.

This request will allow for transfer of confiscated funds appropriation, if needed throughout fiscal year 2018 .

AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND OPERATING EXPENSES FOR THE DEPARTMENT OF ARKANSAS STATE POLICE FOR THE FISCAL YEAR ENDING JUNE 30, 2018; AND FOR OTHER PURPOSES.

## Subtitle
