SECTION 33. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ACADEMIC ENRICHMENT FOR THE GIFTED/TALENTED IN SUMMER PROGRAMS. The Department of Education shall budget, allocate, and spend at least one hundred fifty thousand dollars (\$150,000) of the amount appropriated for Gifted & Talented for Academic Enrichment for the Gifted and Talented in Summer (AEGIS) Programs.

The provisions of this section shall be in effect only from July 1, 2018 through June 30, 2019."

24	SECTION 32. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
25	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. R.I.S.E.
26	ARKANSAS. The appropriation for the R.I.S.E. Arkansas line item in the
27	Grants and Aid to Local School Districts and Special Programs section of this
28	Act shall be used for the coordination of a statewide reading campaign with
29	community partners, parents, and teachers to establish the importance of
30	reading in homes, schools, and communities.
31	The provisions of this section shall be in effect only from July 1,
32	2017 2018 through June 30, 2018 2019.

SECTION 33. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

authorized by this act shall be limited to the appropriation for such agency
