Amend House Bill No. 1073 as originally introduced:

Insert an additional SECTION immediately following SECTION 16 to read as follows:

"SECTION 17. SPECIAL LANGUAGE. NO TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL OR TEMPORARY LAW. SCHOOL CAUTION SIGNS. Immediately upon the effective date of this act, the Arkansas Department of Transportation shall budget, allocate, and expend funds for the installation of caution signs equipped with warning lights at all schools located on the state highway system.

The provisions of this section shall be in effect only from July 1, 2018 through June 30, 2019."

Appropriately renumber the subsequent SECTION numbers of the bill.

SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 1 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. PERSONAL 2 SERVICES MATCHING TRANSFER. Provided that in the event amounts appropriated 3 in the Personal Services Matching line item of the Operations appropriation 4 section are insufficient in the fiscal year to pay the amounts at the rates 5 stipulated by law to be paid for each of these items, an additional amount as 6 determined and requested by the Director of the Arkansas Department of 7 Transportation, and upon review by the Arkansas Legislative Council or Joint 8 9 Budget Committee, will be transferred by the Director of Finance and Administration and the Auditor of State from the Maintenance and General 10 Operation line items to the Personal Services Matching line item of the 11 Operations appropriation section to enable the Arkansas Department of 12 13 Transportation to pay the required matching funds. The provisions of this section shall be in effect only from July 1, 2017 14 15 2018 through June 30, 2018 2019.

SECTION 17. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 19. EFFECTIVE DATE. This act is effective on and after July 1,
