22	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23	
24	SECTION 1. Arkansas Code Title 16, Subtitle 7, Chapter 118 is amended
25	to add a new section to read as follows:
26	16-118-109. Distribution of erroneous background information by
27	<u>certain entities — Civil liability.</u>
28	(a)(1) A private business entity or private person engaged in
29	conducting criminal background checks shall be subject to civil liability by
30	the person about whom the criminal background check was conducted or other
31	aggrieved party if the person or aggrieved party can show by a preponderance
32	of the evidence that:
33	(A) The information disclosed was erroneous; and
34	(B) The disclosure of the erroneous information:
35	(i) Was a proximate cause of an injury to the
36	<pre>person's:</pre>

1	(a) Reputation;
2	(b) Current employment status; or
3	(c) Potential employment status; or
4	(ii) Led to the deprivation of the person's civil
5	<u>liberties.</u>
6	(2) A person who prevails in a cause of action under this
7	section shall be entitled to:
8	(i) Compensatory damages;
9	(ii) Punitive damages;
10	(iii) Court costs; and
11	(iv) Reasonable attorney's fees.
12	(3) The action may be maintained by the person who was injured
13	or damaged or, after the person's death, the executor, administrator, or
14	representative of his or her estate.
15	(b) It is an affirmative defense to a cause of action under this
16	section if the private business entity or person conducting the background
17	check demonstrated heightened due diligence in procuring the most accurate
18	information available at the time the background check was conducted.
19	(c) The remedy provided in this section shall be in addition to any
20	other remedies in law or equity.
