Justice Reinvestment Initiative



What is Justice Reinvestment?

It is a data-driven approach to reduce spending on corrections and reinvest savings in evidence-based strategies designed to increase public safety.



Analyze data

Drivers identified in Phase I:

- Underutilization of probation AR's probation supervision rate was 23% below the national average in 2009
- Long prison sentences for non-violent offenders more than half of inmates were convicted of a nonviolent offense
- Delayed transfer to parole more than half of inmates were held 6 months beyond their presumptive TED



Develop policy options

The working group identified three broad goals for policy development:

- 1. Protect public safety and reduce recidivism by strengthening community supervision
- Improve government efficiency and effectiveness through data collection and performance measurement
- 3. Contain corrections costs by concentrating prison space on violent and career criminals



Pass legislation

- PA 570: The Public Safety Improvement Act of 2011
- Projected to save Arkansas taxpayers \$875 million in averted prison construction and operation costs by 2020



Pass Legislation

Act 570 has 13 components:

- 1. Require DCC to use Evidence-Based Practices
- 2. Allow earned discharge from probation and parole
- 3. Allow DCC to sanction probationers administratively
- Raise probation fees, create "best-practices fund," and study victim restitution
- Improve parole release process and strengthen reporting requirements



Pass Legislation

- 6. Expand Medical Parole
- 7. Accelerate release to Electronic Monitoring for low-level offenders (120 and out)
- 8. Launch HOPE pilots
- 9. Establish the Performance Incentive Funding grant program
- Expand eligibility criteria for drug courts and strengthen reporting requirements



Pass Legislation

- 11. Encourage compliance with the sentencing guidelines and strengthen reporting requirements
- Revise drug statutes to distinguish between drug users and career criminals
- 13. Modernize theft statutes and establish penalties proportional to the offense

Implement new policies

- Modify rules, regulations, and policies
- Train staff
- Educate stakeholders
- Complete system upgrades/modifications



Measure outcomes

- Identify relevant data elements
- Create data collection tool
- Report on outcomes



Reinvest savings

- Agree on reinvestment strategy
- Reach consensus on reallocation of savings
- Calculate reinvestment formula

- Develop the Act 570 Roadmap: identify goals, activities, timelines, challenges, resources, etc.
- igvee ldentify state priorities for seed funding
- Apply to BJA for seed funding



Seed funding

What can the funding be used for?

To kick-start Phase I policies

What does BJA look for?

Capacity-building activities

How much money is available?

Approximately \$200,000 to \$400,000

Seed funding

DCC's approved seed funding:

- Skill-Based Trainings and Education
 Training in evidence-based practices for DCC and ADC
- 2. Technical Assistance in Developing the PIF Grant Program and Planning Grants

 Consultant to assist the BoC in developing the five-site performance incentive funding grant program and planning grants for 10 sites to develop applications to the grant program

3. Implementation of a Place-based Supervision Pilot Program

Tablets for place-based supervision pilot project

4. Assessment of the Implementation of the Arkansas Accountability Interventions Matrix

Consultant to conduct a process evaluation of DCC's ArAIM implementation

High-Level Performance Measures

- Crime rate
- ADC population
- Probation population
- Number of revocations
- County jail backup



Performance measures

Agency-level Performance Measures

- Offenders scored at each risk level
- Offenders on each supervision level
- Earned discharge credits awarded
- Amount generated for best practices fund
- Parole hearings by outcome



Reporting

- Quarterly Tracking Reports
- Monthly check-ins
- Monthly performance measures reports
- Final report to BJA
