Dr. Markham,

The Southern Arkansas University System Board of Trustees approved a FY2023 cost of living adjustment (COLA) of 2.5% for SAU employees during its regularly scheduled meeting June 9, 2022. An estimated cost for the COLA was included in the FY2023 budget presented to and approved by the Board during this meeting. The COLA will only be distributed to employees as an increase to base salaries provided that fall undergraduate enrollment meets budgeted projections.

The most recent COLA SAU employees received was 1.5%. This conservative approach was directly related to uncertainties surrounding the global pandemic. The 2.5% proposed COLA for FY2023 provides the 0.5% salary adjustment that was previously withheld. Due to current inflation and difficulty retaining employees in a competitive job market, the Board and SAU Administration believe a 2.5% COLA is paramount for institutional effectiveness.

I am asking for your approval of the 2.5% COLA for full-time SAU employees for FY2023 under the conditions mentioned above.
