Dear Senator Wallace and Representative Hillman:

The Office of Personnel Management (OPM) presents the Reduction in Workforce (RIF) for the Department of Finance and Administration (DFA), Division of Racing. In accordance with the 2019 decision to end greyhound racing at the West Memphis track by the end of 2022, incumbents within the sixteen (16) positions, six (6) of which are extra help positions, assigned to greyhound racing will be terminated. Upon termination, these positions will be transferred to Oaklawn. The effective date of separation is December 31, 2022.

A total of eleven (11) employees will be impacted by this reduction in force and DFA is currently working to find placement for these employees. DFA has requested severance pay based on years of service for the employees within regular positions that are not placed in new positions. The maximum estimated cost for the severance payments, should zero incumbents find placement, is \$13,200. Additionally, the impacted employees that have not been assigned new positions will be placed on the Reduction in Workforce List and will receive special reemployment consideration as established in OPM state Personnel Policy #64 dated February 12, 2020.
