## **JUSTIFICATION**

The current Chief Fiscal Officer (CFO) for the DPS is the lowest graded CFO within the big six departments. This position requires a high-level of complexity due to a \$389,000,000 budget, grants, Arkansas State Police (ASP) Health Plan, and the day-today operations of supervising all human resource functions for the department. This request for a higher graded position will allow DPS to be competitive with regards to recruitment and retention of qualified employment candidates.

DPS will surrender a currently filled position of Human Resources Administrator and the incumbent in this position will be moved to the current DPS CFO position. Therefore, the expected increase cost is approximately \$33,436.32 including match and the department advises that the cost can be absorbed through direct funding.

The Office of Personnel Management has reviewed the request and **recommends** approval of one position from the OPM surrender pool.
