The Office of Personnel Management (OPM) submits a request for the continuation of previously approved Labor Market Rates for FY24. The requested special entry rates for continuation are attached and are above midpoint for the corresponding pay grade.

The Office of Personnel Management is requesting the continuation of twenty-six (26) Labor Market Rates from five (5) separate departments. These rates were approved so that the departments can attract and retain gualified applicants. Labor Market Rates are also utilized due to labor market conditions for the locations of these classifications. The total amount spent on Labor Market Rates in FY23 was \$202,545.

After review of the requests, the Office of Personnel Management recommends the approval of the continuation of these previously approved Labor Market Rates for FY24.
