The Office of Personnel Management (OPM) submits a request from the Arkansas Department of Health (ADH) for your review.

## **JUSTIFICATION**

ADH is requesting the above positions in order to correct a classification discrepancy within the department. Currently, the incumbents in the three (3) surrendered positions are performing the duties of the ADH Branch Manager classification, which is grade GS11. These employees are responsible for overseeing the administrative, financial and human resources functions of the assigned branch. Although these employees are performing these duties, they are occupying positions authorized at the GS10 pay grade. The addition of the requested positions will allow the department to properly classify and compensate these employees. Approval of this request will result in an anticipated cost of approximately \$25,923, including matching. This amount accounts for promotions of the three current incumbents within the surrendered positions.

## RECOMMENDATION

The Office of Personnel Management has reviewed the request and **recommends** the approval of three (3) surrender pool positions. Your consideration of this request is greatly appreciated.

RE: Request to Upgrade three GS10 Positions to ADH Branch Manager GS11 (L013C)

Currently, there exists an inconsistency within the ADH, where three individuals who fulfill the daties and responsibilities of ADH Branch Managers are not in ADH Branch Manager positions. They are currently in GS10 positions. The ADH Branch Manager is a GS11 position. This discrepancy undermines the recognition and compensation these individuals deserve for their vital role in overseeing the daily operations of their respective branches. By upgrading these individuals to ADH Branch Managers, we align the job classification with the actual responsibilities and ensure consistency in recognizing the level of authority and expertise required for effective branch management.

These individuals carry out the crucial task of overseeing the daily operations of their respective branches, which often comprise multiple sections within the ADH. Their responsibilities include managing Branch budgets, grants, memorandum of agreements, and supervising staff members.

They understand all aspects related to the different sections within their purview. They must possess indepth knowledge of public health practices, regulations, and policies to function as an ADH Branch Manager. Additionally, they serve as agency representatives at legislative meetings, advocating for the department's goals and priorities.

Given the complex and demanding nature of the ADH Branch Manager role for which these employees function, it becomes evident that their responsibilities align with a higher grade than their current GS10 positions. Upgrading these individuals to ADH Branch Manager acknowledges the significant managerial and leadership duties they undertake and the breadth of knowledge required to ensure the efficient functioning of their branches. And most importantly, it eliminates staffing inconsistency.
