The Office of Personnel Management (OPM) submits a request from the Arkansas Department of Education (ADE) for your review.

The Arkansas Department of Education is requesting a certification differential of up to 10% as established by Arkansas Code Annotated § 21-5-221 (g). ADE is requesting this certification differential for the classifications listed below:

## JUSTIFICATION

ADE is requesting a certification differential primarily for employees licensed as Certified Public Accountants by the Arkansas State Board of Public Accountancy (ASBPA). A Certified Public Accountant (CPA) is a designation provided to licensed accounting professionals. To acquire this designation, an individual must meet predetermined education, examination, and work experience requirements. Individuals who undergo these responsibilities and earn their CPA designation are predictably better prepared to handle accounting responsibilities compared with those who do not. Offering a certification differential to specified classifications can enhance the operations within ADE's finance division.

Certified Public Accountant is a professional certification that requires demonstration of accounting knowledge and competence by meeting high educational standards, passing the CPA exam, and completing a specific amount of general accounting experience. A Certified Public Accountant license is a high standard recognized by employers and their clients, governments, and the public as an assurance of skill, dedication, and quality. Continuing professional education in accounting and ethics is required for CPAs to maintain their professional competence and highly skilled and specialized accounting knowledge and judgment.

ADE will offer the following professional certifications to our accounting staff who want to acquire ADE's requested Professional Certification Differential of up to 10% for employees licensed as CPAs by the State Board of Public Accountancy plus, four years of progressively more responsible experience in general accounting or fiscal management on the following classification for FY24:additional knowledge and training in the areas that are very relevant to their employment.

The certification helps ensure that the licensees have knowledge of generally accounting principles and governmental accounting standards, coupled with state and federal accounting regulations and practices for monitoring, budgeting, and managing of public funds.

While ADE does not require this special certification, with the ever-changing complexity of accounting and our business environment, we encourage our staff to gain this level of knowledge in this specific field. The CPA certification is consistently recognized among professionals in the fields of accounting, control, security, and

cybersecurity. ADE has adequate current and ongoing assessments to fund the continuation of this Professional Certification Differential. The ability to retain these employees is critical to ADE and your consideration and approval of the certification differential would be appreciated by me as Secretary of Education.
