Dear Senator Davis and Representative Berry:

The Office of Personnel Management (OPM) submits a request from the Arkansas Department of Public Safety (DPS), a division of the Arkansas State Police (ASP) for the establishment of a labor market rate (LMR) at the maximum for grade GS04, \$42,117, for the classification of ASP Used Motor Vehicle Inspector, X160C.

JUSTIFICATION:

ASP currently has seven (7) positions authorized ASP Used Motor Vehicle Inspectors. Three of the seven positions are at or near the maximum of the pay grade, GS04. Although there are not currently any vacancies for this position, the last two vacancies took approximately six (6) months to fill creating an undue burden on the division as these positions provide inspections into used motor vehicle dealers. Each of the last two vacated positions is currently at a rate of \$37,359.92.

Each position is currently responsible for approximately ten (10) counties. These positions are performing the same duties as Motor Vehicle Investigator, X120C, at a pay grade GS06, which has a pay range of \$36,155-\$52,425.

ASP would like to request a reclassify the positions of ASP Used Motor Vehicle Inspector in the upcoming pay plan, but as a stopgap, ASP would like to request that the classification have an LMR approved at the maximum rate of \$42,117 to stop incumbents from taking higher graded positions with the Motor Vehicle Commission.

The establishment of the requested LMR would be a total cost of \$16,247.01.

The Used Motor Vehicle Division is funded through cash fees and has the funding and appropriation to cover the expenses of this request.

RE: LMR at Maximum for UMVD Inspector

Ms. Barnhill:

The Arkansas Department of Public Safety (DPS), division of Arkansas State Police (ASP) would like to request establishment of a labor market rate (LMR) at the maximum of grade GS04, \$42,117, for the ASP Used Motor Vehicle Inspector.

ASP currently has seven (7) positions authorized as the ASP UMVD inspectors. Three of the seven positions are already paid at the maximum of the grade. Although there is not significant turnover right now in these positions, the last two vacated took approximately six months to fill when they were vacated. This creates an undue burden on the division as these positions are housed regionally across the state to provide inspections into used motor vehicle dealers. On average, each is responsible for approximately 10 counties. Logistically, it is not feasible to pick up another inspector's counties when the position is vacated. Also, these positions are performing the same duties as the Motor Vehicle Investigators, but at two grades lower on the grade scale. ASP would like to reclassify these positions in the upcoming pay plan, but as a stop gap, ASP would request that the classification have an LMR approved at the maximum to stop current incumbents from leaving and taking higher graded positions with Motor Vehicle Commission.

With the establishment of this LMR, there would be a salary cost of \$11,482 and a matching cost of \$2,748, for a total cost of \$14,230. The Used Motor Vehicle Division is funded through cash fees and currently has the funding and appropriation to cover the expense.
