Subject: FY20 Request by Administrative Office of the Courts (AOC) for four Growth Pool Positions.

Dear Senator Wallace and Representative Wooten,

Late in the 92<sup>nd</sup> session, Act 1003 of 2019 was passed adding 5 new state circuit judgeships. Two of the new judgeships begin in Fiscal 2020 and the additional three begin in fiscal 2021. Act 1003 was passed subsequent to the passage of the normal appropriation act (716 of 2019) which provides for one Trial Court Administrator and one Court Reporter for *each* circuit judgeship. To properly staff the two new judgeships beginning July 1, 2019 that were not anticipated by Act 716, the AOC is asking for an addition of 2(two) Court Reporters and 2 (two) Trial Court Administrators for a total of 4 (four) Positions to be provided in FY20 by the Growth Pool authorized by Act 365 of 2017 Section (5) (e)(1).

Accordingly, The AOC petitions the ALC Personnel Committee to favorably consider the FY20 request on the June 18, 2019 Meeting Agenda as follows:

30	being necessary for the preservation of the public peace, health, and safety
31	shall become effective on July 1, 2019.
