Individuals with the certifications listed above are highly desirable and difficult to recruit and retain. Certification differentials are not considered a part of an employee's base pay; if the employee moves from a classification eligible for the differential to a position ineligible for the differential, the employee will no longer receive the differential. The cumulative differential an employee can receive pursuant to this request cannot exceed 10%. DFA estimates that the cost of the differential will be approximately \$192,319.

After review, the Office of Personnel Management recommends approval of DFA's request for certification differentials for being a Certified Public Accountant or a Certified Government Financial Manager for Fiscal Year 2020 for the aforementioned classifications.
