### **JUSTIFICATION**

The Department of Finance and Administration is requesting the position above as a result of the absorption of the Arkansas Tobacco Control Board that merged with the divisions of Alcohol Beverage Control Administration and Alcohol Beverage Control Enforcement. This merger required the restructuring of these combined divisions. The requested position will be responsible for overseeing a new Criminal Investigation Division that will investigate all tobacco, alcohol, and medical marijuana laws. This position will also recruit and train of all enforcement agents while supervising two Senior Auditors, nine Enforcement Agents/Criminal Investigators, and one Senior

Intelligence Analyst. This position will report directly to the Department of Finance and Administration Regulatory Administrator.

The potential cost of the additional position is \$81,953 (\$62,531 plus 23%). In order to help offset the budgetary impact of this change, DFA is surrendering three vacant, budgeted positions with a budgetary value of \$90,497.
