JUSTIFICATION

The Arkansas State Crime Laboratory is requesting the above additional Forensic Scientist positions in order to eliminate backlog issues the agency is currently encountering. Since 2015, the agency has experienced a 27% increase is drug case submissions. This has resulted in a backlog of 8,500 cases. The current processing time for each of these cases is approximately six months. The prolonged processing time has resulted in court date delays and issues with conducting timely trials. The agency projects that, if the above pool positions are approved, they will be able to reach a 30 day turnaround time in 17 months after the completion of training.

Re: Position Upgrade Request

Dear Ms. Barnhill:

I am requesting that two Administrative Specialist II positions (GS03) be upgraded to Forensic Scientist positions (GS08) in order to hire additional Forensic Chemists. Below is my justification for this request.

The Arkansas State Crime Laboratory services all 75 counties which include over 400 state and federal law enforcement agencies. The case submissions and demands for our forensic science services have drastically increased since 2014 with an increase of 17% over the last four years with no additional staffing. In 2017, our overall laboratory backlog increased by 44%.

The growing concern is the number of drug case submission which has increased 27% since 2015, resulting in a backlog of 8,500 cases with a turn-around time up to 6 months, which is unacceptable. With the current staff in the Drug Section, it will take 173 months to reach a 30 day turnaround time. If we are able to hire the Forensic Scientist positions requested above, we project that we will be able to reach a 30 day turnaround time in 17 months after the completion of training.

Recently the Governor's Office asked what is being done about the backlog and the practical implications. The implications are the slowdown of the criminal justice system, postponing court dates and speedy trial issues.
