Arkansas State University – Beebe (ASUB) requests the establishment of nine (9) non-classified positions from the Higher Education Central Pool authorized by Act 599 of 2017, ACA §21-5-1415. In accordance with the provisions of the Act, we are forwarding our recommendation to you for consideration.

As you are aware, over the last couple years ASU-Beebe has gone through a fairly extensive administrative and academic reorganization. As a result of these changes, we have several nine-month faculty now in twelve-month slots. In an effort to better align appropriated positions to the new faculty structure, ASU-Beebe would like to request an additional nine (9) nine-month faculty positions from the non-classified central pool.

The current literature suggests that the quality and frequency of academic advising positively correlates to increased student retention and completion rates. The increase in the number of nine-month faculty positions will assist the institution in aligning the advising needs of our students to the available advising resources. The additional nine-month faculty will have the ability to serve as academic advisors. By fully utilizing a professional advisor/faculty advising model, we are better able to serve students and positively impact student retention while keeping resource costs as low as possible.
