### Justification

UCA has recently implemented new masters and doctoral level curriculums without the addition of academic counselors. Additionally, the UCA Board of Trustees has recommended that UCA develop a program aimed at improving our retention rate. UCA has followed that recommendation by re-structuring our academic advising center and initiating a program requiring all Colleges have a permanent academic counselor to provide specific advising to majors.

### **Educational Requirements**

Master's degree in appropriate field, other job related experience and education may be substituted.
