The Office of Personnel Management (OPM) submits a request from the Arkansas Insurance Department for your review.

JUSTIFICATION

The AID is working to restructure the agency and requests the above pool positions in order for the agency to reorganize in the most efficient manner. The agency is requesting these swaps to avoid increasing the number of personnel, to avoid further reductions in their workforce and to assist in the restructuring of the organization.

Due to the level of responsibility and professional interactions that will be required of the AID Public Information Officer, the agency requests a grade C127.

Dear Kay,

This will serve as a follow-up to our meeting on Wednesday, May 11, 2015. The following outlines my understanding of the items discussed at that meeting. All these requests are continuations of the reorganization I am implementing at the Insurance Department.

Thomas Herndon: The Department would like to surrender a vacant C110 position and request a pool position of Insurance Life & Health Compliance Officer, C118. This request is being made as a result of the transition of some personnel and duties to AHIM. Thomas is in charge of the specialized licensing and training of all personal assisters, brokers and other personnel marketing through the exchange. While many of the functions will be moved to AHIM over the next 18 months or so, the unique mix of federal and state requirements for licensing will mean that this becomes a regulatory function which will remain a duty of the Insurance Department. Thomas is currently in a grant position but it will be necessary for this duty to continue as a Department function; thus, the request for the position swap to allow a salary continuation so we can retain him.

Chantal Albritton is currently a Grants Coordinator at a C119 and will be moving into a full-time Department position as an Insurance Life & Health Compliance Officer which is a C118. She will be using her experience gained in the marketplace to continue to review form submissions submitted for use by AHIM. This is a regulatory function that will need to continue to stay with the Department. We request a salary continuation for Ms. Albritton.

Alice Jones, our Communications Director, will be retiring July 1, 2015. As a part of the reorganization, I plan to restructure the duties of the Communications Director so that all external communications on behalf of the Department will be handled by this person. Ms. Jones is currently a C123 (career level) and my request is to swap the C123 for a new C127 position, AID Public Information Officer.
