Dear Ms. Terry:

Act 715 of 2015 established for the Department of Information Systems (DIS) the maximum number of employees for FY 2015-2016. The 2015 Regular Session and the First Extraordinary Session brought restructuring of DIS which included the transfer and absorption of certain duties and responsibilities also affecting the Department of Education and Arkansas Geographic Information Systems Office. With the restructuring, at least one (1) position was eliminated in FY 2016, and two (2) positions were directly affected by lack of general revenue funding. The restructuring will allow the departments to perform statutory obligations more efficiently. Effective June 30, 2015, the following positions and personnel were eliminated through a Reduction in Force:
