## **JUSTIFICATION**

The Arkansas Agriculture Department – Arkansas Forestry Commission is requesting to surrender two positions listed above and requests two positions of State Forester, B058C of grade C1119 from the position pool and will relinquish one AFC Investigator and one Staff Development Coordinator positon. The AFC employs certified law enforcement investigators with cases such as arson and timber theft. Staff Forester for the agency would be a tremendous asset to communicate the mission and responsibilities of the Arkansas Agriculture Department. By approving this request would improve the agency's ability to assist farmers and ranchers throughout the state, effectively market and promote the agricultural industries plus increase the economic impact for the state of Arkansas. The AFC has the funds available to cover the costs of the requested positions.

Dear Kay:

Please consider the following 2 personnel requests, both of these positions are extremely important to the safety and fire protection preparedness of our agency.

### **Firewise Coordinator**

As you know we recently promoted our experienced and successful Firewise Coordinator (Staff Forester, C119) to our Staff Training Officer which has been a (Staff Development Coordinator, C117). In order not to lower our 30+ year experienced employee's salary we have adjusted his job description and retained him in his current position as a (C119). The Firewise Coordinator position that he is vacating is of equal importance to our citizens. We request a pool position which would be a Staff Forester (C119), and will surrender the Staff Development Coordinator (C117). This will result in a net annual salary gain of \$4,972.00, and no net gain of positions.

#### Law Enforcement Supervisor

The AFC employs 3 certified full-time Law Enforcement Investigators. We also train and deploy 11 of our field fire personnel to assist the 3 Law Enforcement Investigators with cases such as arson and timber theft. Since 2011 one of the 3 full-time investigators has lead all training and tasking for the 2 other full-time investigators as well as the 11 field personnel, Essentially, he has acted as their supervisor. We request a pool position which would be a Staff Forester (C119), and will surrender the (AFC Investigator, C117) which he currently holds. This request recognizes the supervisory work that this employee has been doing for more than 4 years. If approved, our request will result in a net annual salary gain of \$3,746.00, and no net gain of positions.

The AFC easily has the funds available today and in the future to cover this total net annual salary gain of \$8,718.00.
