Utilization of Temporary Pool Positions

Dear Senator Lindsey and Representative Fite:

Pursuant to Act 717, Section 15(b) of the 90^{th} General Assembly, I am writing to report the utilization of the authorized temporary pool positions by the Arkansas Public Employees Retirement System for the first quarter of fiscal year 2017 (07/01 – 09/30/16) and the totals for 16/17 biennium-to-date. Copies of the relevant pages of the act are enclosed for your convenience.

Nine of the ten authorized positions were utilized during this period as reflected in the table below:

- 32 (a) To address temporary staffing needs during the 16-17 biennium due
- 33 to the (1) implementing a new pension administration system (COMPASS) and (2)
- 34 meeting the new Governmental Accounting Standards Board (GASB) #67 (Financial
- 35 Reporting for Pension Plans) and #68 (Accounting and Financial Reporting for

authorized for the 2015-2016 fiscal year, a pool of no more than ten (10) 1 classified grade C117 level positions at base level pay of \$32,249 each. 2. Positions established during the 2015-2016 fiscal year would be continued 3 into the 2016-2017 fiscal year, along with the remainder of the available 4 positions in the pool. All positions would sunset as of 6/30/17. All 5 position advertisements shall clearly state the temporary employment period 6 and hired individuals shall sign a disclosure form acknowledging the 6/30/17 7 8 end date. (b) The Arkansas Public Employees Retirement System is authorized to 9 access the pool positions authorized in this Section at any time it is 10 determined by the Executive Director that the need exists to provide for 11 continuity of services during those implementation heavy periods of time. 12 The Executive Director shall provide a quarterly report of the number of 13 positions utilized and associated salaries to the Chief Fiscal Officer of the 14 State and to the Arkansas Legislative Council for review. 15 (c) Determining the number of personnel to be employed by a state 16 agency is the prerogative of the General Assembly and is usually accompanied 17 by delineating the maximum number of personnel by identifying job titles and 18 the maximum grade or salary attached to those titles. The General Assembly 19 has determined that the Arkansas Public Employees Retirement System could 20 utilize these positions to better accomplish the major initiatives faced by 21 the Agency during the 16-17 biennium by providing the temporary position pool 22 in Subsection (a) of this Section. The General Assembly shall maintain 23 oversight of the utilization of the position pool by requiring review of the 24 Legislative Council. Therefore, the requirement of review by the Legislative 25 Council is not a severable part of this Section. If the requirement of 26 review is ruled unconstitutional by a court of competent jurisdiction, this 27
