The Office of Personnel Management submits a request from The Arkansas Department of Health (ADH) for your review.

The Arkansas Department of Health (ADH) has requested the establishment of a labor market special entry rate for the following classification due to an emergency epidemic:

## **JUSTIFICATION**

The special entry rates for this classification is based on problems of recruitment, training, and retention of employees. The agency has requested that this rate only apply to 52 positions located in Benton, Washington, and Pulaski counties (see attached list of position numbers). The need to maintain public health nursing staff is critical in these counties due to a high rate of communicable disease outbreaks such as tuberculosis and mumps. These nurses are specially trained in communicable disease prevention, detection, contact investigations, surveillance, and treatment. The turnover rates for these three counties in the last two years has been between 57-78%.

Based on analysis of these positions, the Office of Personnel Management (OPM) **recommends** the labor market rate of \$62,616 through Fiscal Year 2017 due to the critical need and public health impact. Your consideration of this request is appreciated.

Re: Requesting Labor Market Rates for C120 in areas of the state with high turnover and communicable disease rates or outbreaks

#### Dear Kay:

The Arkansas Department of Health is requesting the authority to adjust registered nursing staff annual salaries in Benton, Washington and Pulaski counties up to \$62,616, the maximum level for the grade. The need to maintain a public health nursing staff in these counties is critical due to a high rate of communicable disease outbreaks such as tuberculosis and mumps, combined with ongoing recruitment and retention challenges for registered nurses. A public health nurse is specially trained in communicable disease prevention, detection, contact investigations, surveillance and treatment.

In FY16 Benton, Washington and Pulaski counties had 14,449 visits for tuberculosis which accounted for 52% of all the TB visits in the state. The current mumps outbreak combined with staff shortages has necessitated redirecting nursing staff from across the state to NW Arkansas. Even with rigorous recruitment efforts, turnover rates for registered nurses in these counties have been consistently over 50% and as high as 71% over the last two years. Similarly, Pulaski County has a high rate of communicable diseases that requires retaining a trained public health nursing staff to address the health consequences.
