## STATE OF THE SOUTH DAKOTA CRIMINAL JUSTICE SYSTEM IN 2004

- FOR DECADES ALCOHOL AND DRUGS HAVE BEEN FUELING THE CRIMINAL JUSTICE SYSTEMS
- ESCALATING JAIL AND PRISON POPULATIONS W/O A TAX BASE TO SUPPORT BUILDING NEW JAILS AND PRISONS – A FINANCIALLY AND SOCIALLY UNSUSTAINABLE SITUATION
- INMATE DEMOGRAPHICS: 36% OF THE PRISONERS ARE FELONY DUI AND 31% OF INMATES ARE CONTROLLED SUBSTANCES FELONS
- NEARLY HALF OF ALL FATAL CRASHES WERE ALCOHOL RELATED AND ONE OF THE HIGHEST ALCOHOL RELATED FATAL AND INJURY CRASH RATES IN THE NATION
- 85% OF THE PRISON POPULATIONS IN SD HAVE AN ADMITTED ALCOHOL OR DRUG PROBLEM
- 830,000 POPULATION AND 50% OF THAT GROUP DEFINED AS RURAL

# THINKING OUTSIDE THE BOX TO FIND ANOTHER DIRECTION THE 24/7 PROGRAM (AN IDEA WHO'S TIME HAD COME)

- GOVERNOR'S CORRECTIONS TASK FORCE AND ATTORNEY GENERAL LARRY LONG
- FRONTING THE IDEA OF 24/7 MONITORING WITH A SURE, SWIFT, AND MEASURED CONSEQUENCE FOR NON-COMPLIANCE OF PROGRAM RULES EFFECTING CHANGE AND BEHAVIOR MODIFICATION (CRITICAL COMPONENT TO THE SUCCESS OF 24/7.
- DEFINING OBJECTIVES:
  1. KEEP PARTICIPANTS SOBER AND CLEAN 24/7
  2. REDUCE INCARCERATION RATES (LOCAL AND STATE)
  3. REDUCE ALCOHOL AND DRUG RELATED INJURY AND FATAL CRASHES
  4. REDUCE DUI RECIDIVISM RATES AND CRIME OVERALL
  5. SAVE TAXPAYER DOLLARS BY USING A PARTICIPANT PAY MODEL, DEVELOP LOW PRICE POINTS FOR TESTING METHODOLOGIES SO TESTING IS AFFORDABLE  
(NOTE.....SD RANKS 46<sup>TH</sup> IN THE NATIONS PER CAPITA INCOME)
  6. SUPPORT TESTING FOR SPECIALTY COURTS
  7. KEEP PARTICIPANT WORKING AND PROVIDING FOR FAMILIES
  8. SET THE STAGE FOR LONG TERM SOBRIETY AND BEHAVIOR CHANGES WITH TREATMENT PROTOCOLS AND RETURN OF COGNITIVE SKILLS
  9. TEST AGENCIES HAVE EXPENSES OFFSET WITH PARTICIPATION FEES AND AGENCY PARTICIPATION IS VOLUNTARY

# TARGET GROUP AND GETTING STARTED

- AGAIN Participant sobriety- 24/7 (NO ALCOHOL NO DRUGS NO BARS)
- ( 5 county pilot Feb. 05) Anyone arrested for DUI 2<sup>nd</sup> or more 24/7 imposed as a condition of bond
- USE QUICKLY ESCALATED AND EXPANDED BY JUDGES and now (with legislation) used as a bond condition or post sentence/probation for offenses having a nexus to alcohol or drug abuse, high BAC first offense DUI, DUI 2 or more, vehicular homicide, vehicular battery, prison parole any offense, family courts , domestic violence, DUI court/drug court, and reinstatement of driving permit after suspension or revocation.

  - OTHER BREATH TESTING DEVICES

# SD BREATH TESTING RESULTS

(LATEST PUBLISHED STATS 2/05 – 6/1/2015)  
(twice per day is the backbone of 24/7 testing)

- 37,291 PARTICIPANTS PLACED ON 2 x DAY TESTING
- 85% of the alcohol testing participants are 2xday
- APPROXIMATELY 2,500 ACTIVE PARTICIPANTS EACH DAY
- ADMINISTERED 7.79 MILLION TWICE PER DAY TESTS
- PASS RATE OF 99.1%
- .45% FAILED THE BREATH TEST
- .45% DID NOT SHOW FOR TESTING
- \*7.79 MILLION TESTS / 2 = 3.9 M DAYS x \$80 PER DAY JAIL COSTS = MILLIONS IN SAVINGS?

# TRANSDERMAL STATISTICS

OCTOBER 2006 – JUNE 2015

- PARTICIPANTS USING A TRANSDERMAL DEVICE 7,667
- TOTAL DAYS MONITORED 1.3 MILLION
- AVE. LENGTH OF TIME ON BRACELET 140 DAYS
- FULLY COMPLIANT 76%
- NON COMPLIANT 24%
- NON COMPLIANT MEANS A CONFIRMED DRINKING EVENT OR A CONFIRMED TAMPER OR BOTH

- 5,394 PARTICIPANTS
- 132,778 TESTS ADMINSTERED
- PASSED RATE 96%

### MT. PLAINS EVAULATION

STUDY SANCTIONED BY NHTSA AND DEMONSTRATED A 50% PLUS REDUCTION  
IN RECIDIVISM RATES (long term) FOR PARTICIPANTS PLACED ON THE 24/7  
PROGRAM

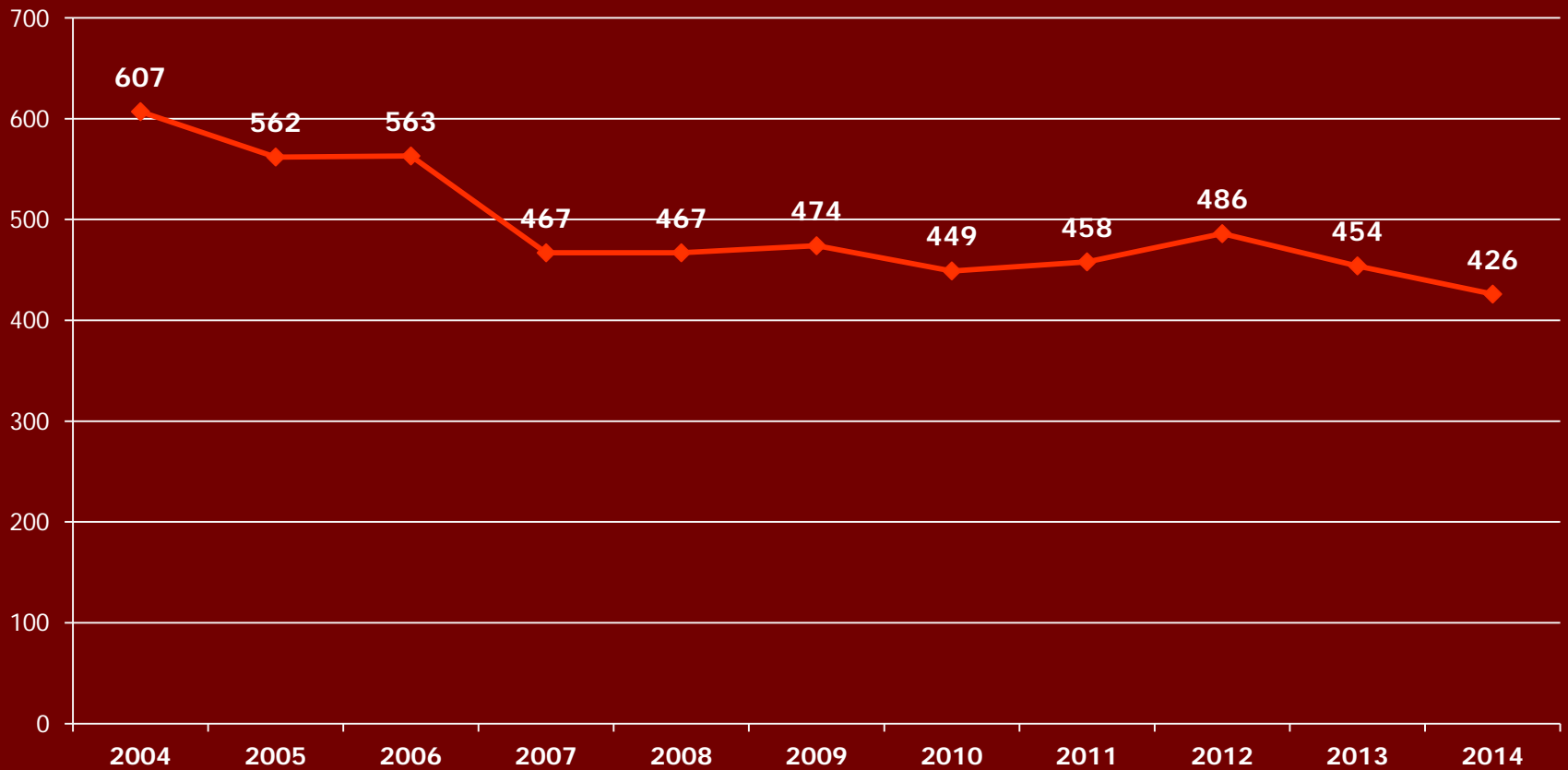
- REDUCTION IN DUI RECIDIVISM

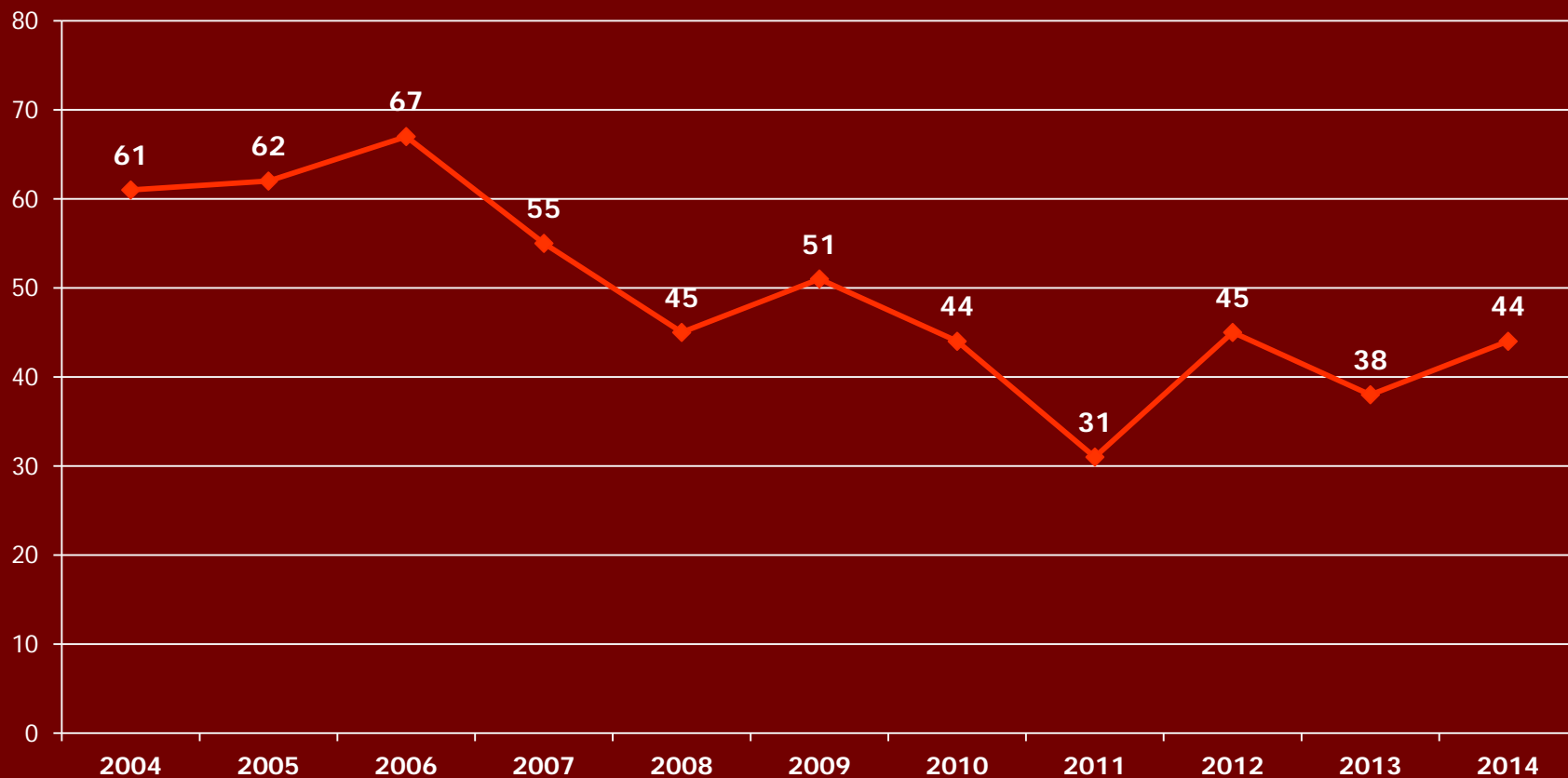

## ALCOHOL RELATED FATAL CRASHES

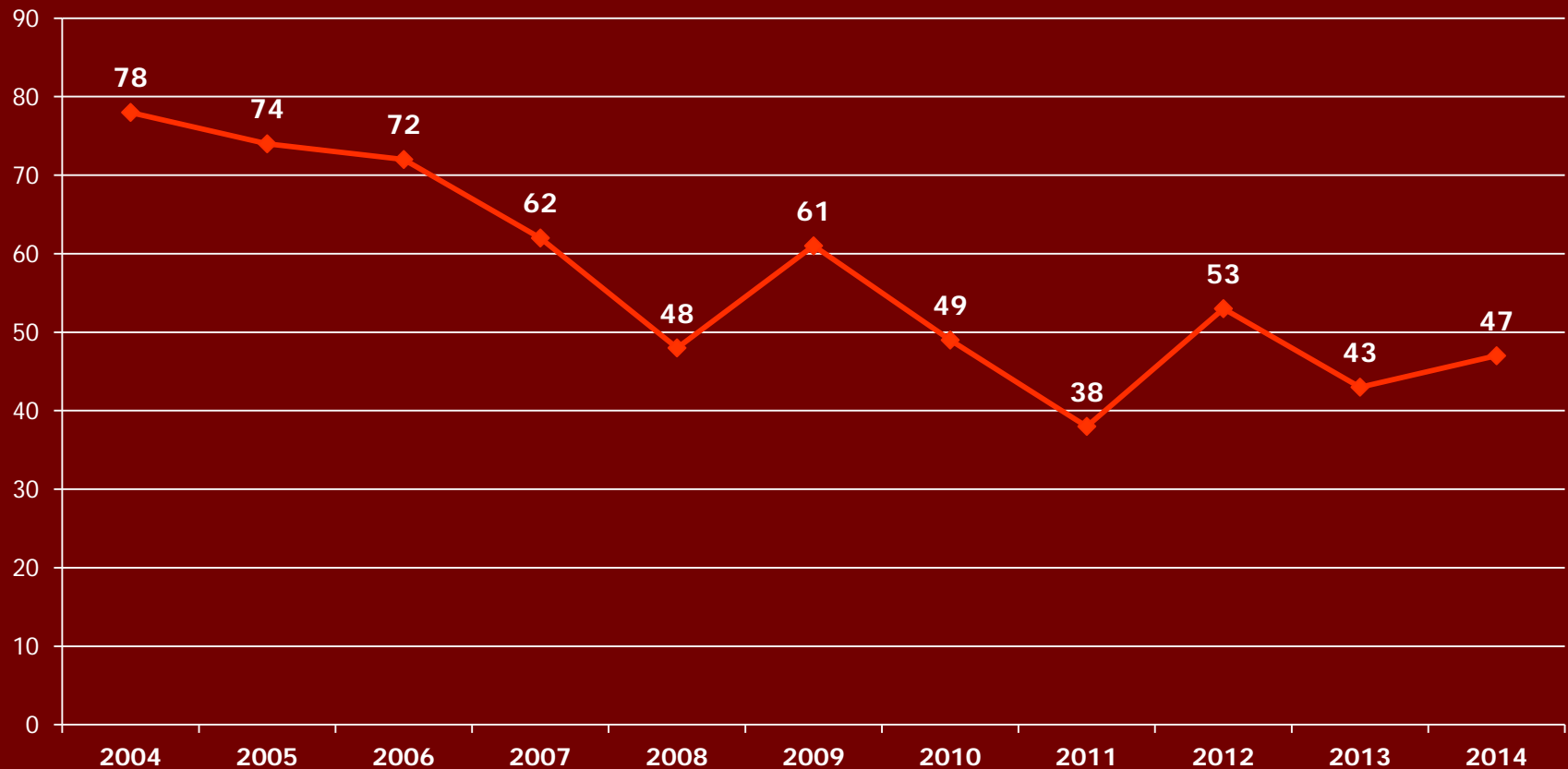

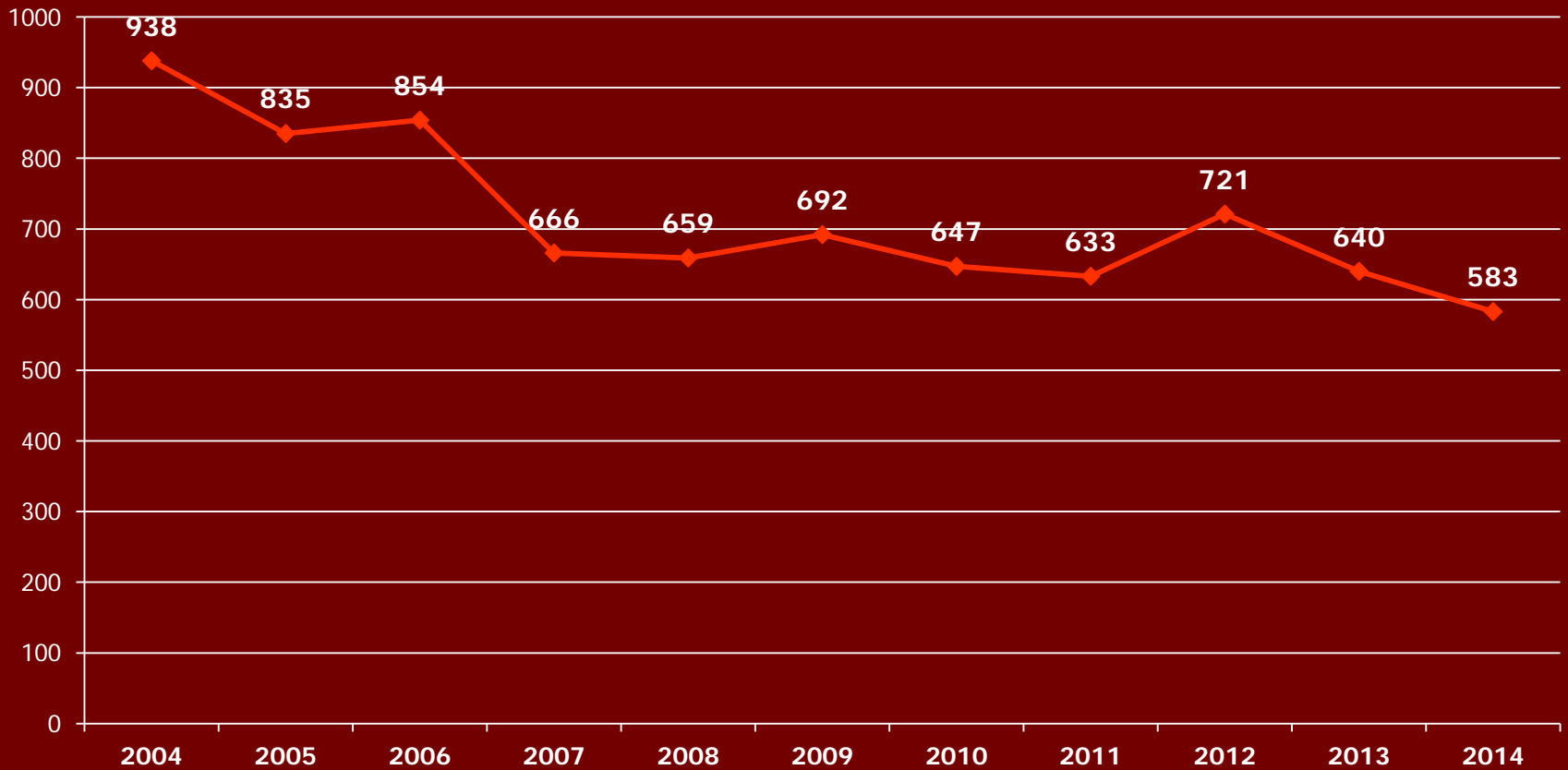

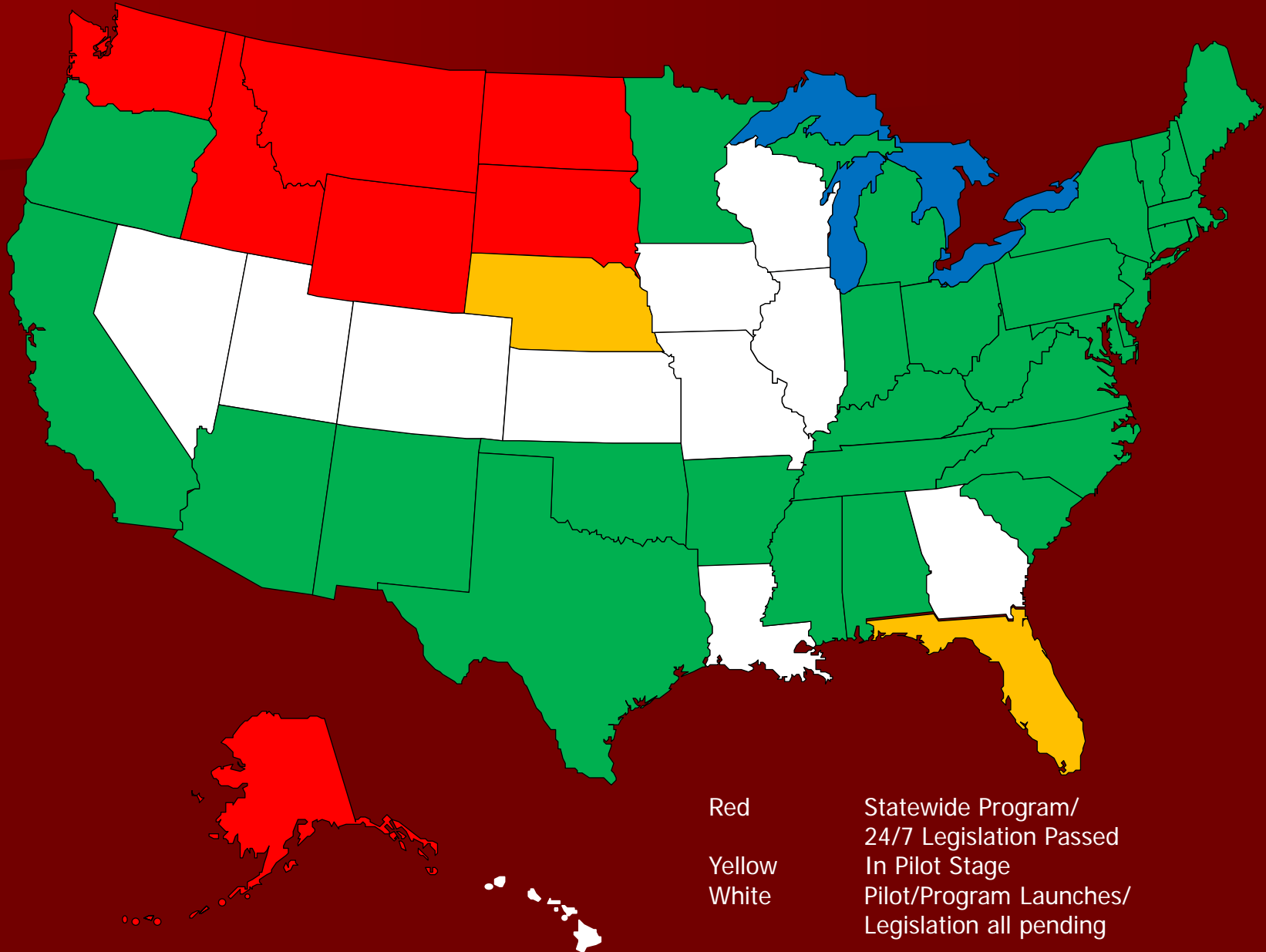
- REDO OF SENTENCING GUIDELINES AND CORRECTIONS POLICIES
