21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23	SECTION 1. The introductory language of Arkansas Code § 6-23-306,
24	concerning the contents of open-enrollment public charters, is amended to
25	read as follows:
26	(a) An open-enrollment public charter granted under this subchapter
27	shall:

29	SECTION 2. Arkansas Code § 6-23-306(6)(B), concerning weighted lottery
30	admissions for open-enrollment public charter schools, is amended to read as
31	follows:
32	(B) The open-enrollment public charter school may allow a
33	weighted lottery to be used in the student selection process:
34	$\underline{\text{(i)}}$ when $\underline{\text{When}}$ necessary to comply with Title VI of
35	the federal Civil Rights Act of 1964, <u>42 U.S.C.</u> § 2000d et seq., Title IX of
36	the federal Education Amendments of 1972, 20 U.S.C. § 1681 et seg., the equal

1	protection clause of the Fourteenth Amendment to the United States
2	Constitution, a court order, or a federal or state law requiring
3	desegregation; and or
4	(ii) For an increased chance of admission of the
5	following students:
6	(a) National school lunch students, as defined

8	(b) English-language learners, as defined
9	under § 6-20-2303;
10	(c) Students with disabilities under the
11	Children With Disabilities Act of 1973, § 6-41-201 et seq., or the
12	Individuals with Disabilities Education Act, 20 U.S.C. § 1400 et seq.; and
13	(d) Students who are currently enrolled in a
14	public school that is classified as being in academic distress; and

16	SECTION 3. Arkansas Code § 6-23-306(14)(C), concerning weighted
17	lottery admissions for open-enrollment public charter schools, is amended as
18	follows:
19	(C) The open-enrollment public charter may use a weighted
20	lottery in the student selection process only when necessary to:
21	(i) comply When necessary to comply with a:
22	(i)(a) Federal court order; or
23	(ii)(b) Federal administrative order issued by

7	SECTION 4. Arkansas Code § 6-23-306, concerning contents of open-
8	enrollment public charters, is amended to add an additional subsection to
9	read as follows:
10	(b)(1) If an open-enrollment public charter includes the use of a
11	weighted lottery under this section, the structure, format, and operation of
12	the weighted lottery shall be subject to the sole discretion and control of
13	the open-enrollment public charter school governed by the open-enrollment
14	public charter.
15	(2) An open-enrollment public charter that includes the use of a
16	weighted lottery under this section may provide that the weighted lottery be
17	operated and managed by the Department of Education.
