Remarks by the Chairs

Representative Cozart and Senator Jane English, the Chair of the Senate Committee on Education, commented on the excellence of the committee meeting hosted the previous day by the Arkansas Educational Television Network (AETN) in Conway, Arkansas.

Introduction of the Adequacy Study Process

<u>Presenter</u>: **Ms. Nell Smith**, Administrator, Policy Analysis and Research Section, Bureau of Legislative Research, was recognized. Ms. Smith stated the responsibility of the Section is to walk the Committees through the required statutory responsibilities and provide requested information. She described the process to be used for the next 18 months to complete the statutory requirements for the Study. Adequacy Study Process; Roles; Other Organizations' Roles; Study Components; BLR Reports; Timeline; Proposed Meeting Schedule (*Exhibit D3*); Recommendations Worksheet (*Exhibit D4*) and Final Report; and Fiscal Session Responsibilities.

Discussion of Request for Proposal (RFP) to Conduct the Adequacy Study

Senator Linda Chesterfield was recognized, and made a motion to authorize the Bureau of Legislative Research (BLR) to begin the procurement process for adequacy consulting services. The motion was seconded by Representative Stephen Meeks.

A lengthy discussion ensued pertinent to hiring an outside consultant versus conducting an in-house study, funding issues, and the timeline for the process. The discussion included suggestions for changes in the language of the RFP, for methods used to determine what constitutes an adequate education, and for achieving cohesiveness in vision for the RFP.
