Ms. Holt referred Committee members to the Adequacy Tracking Sheet (*Handout C2*), which notes all topics required be covered in the Adequacy Study. She then reviewed the Arkansas Educational Support and Accountability Program (AESAP), the state's accountability system for public schools and school districts, which runs parallel to the federal system under the Every Student Succeeds Act (ESSA). Utilizing a PowerPoint presentation, Ms. Holt reported on issues including *Why Hold Schools Accountable? What Is School Accountability? How Is AESAP Implemented? Soft Accountability and Letter Grades, Reward Schools*, and *Adequacy Outcomes Related to Educational Accountability*.
