Mr. John Hoy, Assistant Commissioner, Division of Academic Accountability, Arkansas Department of Education, was recognized. Mr. Hoy addressed questions prepared by the Bureau of Legislative Research (BLR) for the Arkansas Department of Education (ADE). With regard to No Child Left Behind, he discussed the following: 1) Alignment with previous school improvement system, 2) Use of school improvement consultants, 3) Rewarding exemplary schools, 4) Student growth measures in teacher evaluations, and 5) ESEA reauthorization proposals.

Issues Included in the Discussion:

- the federal school choice option(s),
- guarantees provided to school districts to ensure students are immersed in necessary skills,
- safeguards provided to make sure of gains each year,
- interim measurable objectives for school improvement,
- addressing individual needs of students,
- funding used for hiring outside school improvement consultants,
- clarification of designation criteria,
- effect on school districts of the waiver to remove supplemental services,
- how contracts are given to external providers,
- assessing the impact of supplemental service providers,
- solutions to impact individual students, including those in priority schools and focus schools,
- issue of hiring new teachers every year in "labeled" school districts,
- what ADE is doing in the Helena-West Helena School District and what's working,
- funding mechanisms and other resources for the implementation of needed programs to change outcomes for students in priority schools,
- correlation between academic distress and financial distress, and related issues,
- looking at areas of innovation and sharing ideas for building a collaborative resource bank,
- challenge of metrics when a label is attached,
- existence of indicators other than those tied to accountability,
- evaluating the performance of external providers before including them on the approved list,
- use of external providers reflected in a district's Arkansas Comprehensive School Improvement Plan (ACSIP),
- using retired educators as a resource in a community with a school in school improvement,
- availability of written criteria to determine the success of collaborating with external providers,
- issue of school compliance or school improvement, and
- school districts worked in by Mr. Hoy and Mr. Harvey and their track record for turning around schools.

- ≈ annual accountability report from each school to determine if the school maintains a status of priority or a status of distress,
- ≈ unintended negative consequences of the academic distress label, and
- ≈ timeline for changes leading to a school district being designated in academic distress.
