Discussion of Issues Related to School District Resource Allocation

Presenter:

Ms. Nell Smith, Administrator, Policy Analysis and Research Section, Bureau of Legislative Research, was recognized. Ms. Smith referred to highlighted items on a handout of Adequacy Study statutory responsibilities, and said the presentation today would cover the Bureau of Legislative Research (BLR) report, *The Resource Allocation of Foundation Funding for Arkansas School Districts and Open-Enrollment Charter Schools*. She stated the purpose of this report is to review the way school districts spend the foundation funding they receive. She referred to a pie chart on page 4 of the report that shows how schools in Arkansas are funded. She said the total funding for school districts is \$4.95 billion, with about 58% of that amount coming from foundation funding. Ms. Smith gave a quick overview of how the foundation funding amount is calculated, then reviewed the Matrix line by line to show how school districts' spending patterns match the intent of the Matrix. She stopped

periodically for questions as she walked the Committees through the report. Her discussion during the first session included, but was not limited to: School-Level Staffing and School-Level Administration Personnel.

Issues Included in the Discussion:

- clarification of state ranking as outlined in charts on pages 9 and 10,
- number of principals in poverty schools,
- baseline for offering civics and American government,
- paying teachers less in poverty districts,
- National School Lunch Act (NSLA) funding,
- per-student amount of foundation funding used to pay for teacher salaries,
- defining Adequacy,
- spending differences for charter schools vs. traditional schools,
- necessity of balancing the local autonomy of school districts with state obligations to ensure an adequate education for all students,
- clarification on numbers and roles of school nurses; how schools categorize nurses,
- assistant principals,
- recruitment, remuneration, and retention of special education teachers in high poverty school districts,
- Medicaid funding for student support services,
- role of instructional facilitators and tracking their impact,
- setting the average salary of a librarian or a media specialist,
- arriving at the base salary for the funding of nurses,
- number of special education students enrolled in Arkansas as compared to other states,
- calculations used to determine the number of librarians needed to be in compliance with Adequacy,
- adjusting numbers in the Matrix or to the funding of the Matrix for SY2015-16, and
- funding for other school staffing.

Recess:

Senator Key announced that the Committees would recess for lunch until 11:15 a.m.

11:15 a.m. Session

Senator Key called the meeting back to order at 11:15 a.m.

Presenter:

Mr. Richard Wilson, Assistant Director, Research Services, Bureau of Legislative Research, was recognized. Mr. Wilson stated that today's report compares the Matrix to how districts actually spend the foundation funding they receive. He said the good news is that there's a higher correlation than expected. He noted that in the conclusion to the report it says that while foundation funding is a major source of funding for school districts, it makes up only about 58% of districts' total funding. He commented that this is the fifth report since recalibration, and noted a new tool was used for completing the report that helps provide additional ways to look at data and collect extra information. Mr. Wilson added that the contract with Picus Odden and Associates has been signed, and that this report will be utilized in the formulation of their analysis. Mr. Wilson next discussed the remaining schedule for reports:

August 12 three final reports: Time on the Bus, Isolated Funding, and Transportation Cost Model

September 9 Picus Odden and Associates desk audit presentation

October finalize Adequacy Report for November 1

November 1 final Adequacy Report due

Senator Key said the draft Adequacy Report will be sent out in September, allowing time to review and act on the Report before its submission on November 1. He stated the Adequacy Report will be a critical component of the Governor's balanced budget proposal.

Ms. Smith continued her review of the Resource Allocation, discussing the following topics: School-Level Resources, District-Level Resources, District Comparisons, Total Per-Pupil Expenditures, and Fund Balances.

- * state by state comparisons for technology and extra duty,
- * paying for substitute teachers through sub-contracted substitute placement companies,
- * stocking libraries with electronic books.
- * availability of \$500 for purchase of instructional materials getting to teachers,
- * benefits for long-term substitutes,
- comparison of sick and personal days for public school employees, other state agencies, and private sector
- * including a classroom teacher or representative in a local school's budgeting process,
- * availability of statistics on use of libraries,
- * correlation between the poverty level of students and use of e-books,
- * school districts' classification (coding) of Broadband expenditures,
- * breaking down extra duty,
- dispersal of funds coming in from extra duty,
- * salary range of athletic directors,
- * mechanism included in the Matrix for funding of non-teaching personnel to do non-classroom duty,
- * providing adequate planning time for those expected to deliver an adequate education to students,
- * instructional aides having a positive impact if they have the proper training and supervision, but the "if" remains at the discretion of the districts,
- * funding for high school agricultural programs and high school chemistry class labs,
- * hearing the voices of high-poverty district personnel regarding policies that improve student achievement,
- * comparison of expenditures for purchased vs. other types of services,
- * salary range for superintendents, and rankings by school district,
- * correlation between the poverty-level and small schools,
- * closing the gap between large schools and small schools,
- * comparisons on spending per pupil with SREB (Southern Regional Education Board) states,
- clarification of unrestricted fund balances.
- * declining fund balances and fiscal distress,
- * growth in the number of administrative personnel in school districts, and
