Reports from Members Who Attended Recent Meetings Concerning Public or Higher Education

The Honorable Joyce Elliott, State Senator, District 31, and Vice Chair of the Senate Committee on Education, was recognized, and reported on the Legislative Summit of the National Conference of State Legislatures (NCSL) held August 19-22, 2014 in Minneapolis, MN. Senator Elliott commented on hearing a discussion on education from Sir Ken Robinson, an English author, speaker, and international advisor on education in the arts. She noted education sessions included the future of higher education and the implications for states and students, data privacy and waivers, and the arts in education and in the workforce and what that could mean to economic development. Senator Elliott stated that Arkansas has been chosen by Americans for the Arts to join a three-year pilot program to strengthen advocacy of arts education. She said that as a part of the program the Arkansas team will get a \$10,000 direct grant each year. Senator Elliott said she also attended a meeting of a small study group that has begun looking at international education and what can be learned from high-performing countries.

**The Honorable Charles L. Armstrong**, State Representative, District 30, was recognized. Representative Armstrong reported on the 2014 Annual Conference of The Council of State Governments (CSG) held in Anchorage, Alaska in August. He stated the discussions at education meetings centered on workforce education and training programs at two- and four-year colleges and institutions.

**The Honorable Nate Bell**, State Representative, District 20, was recognized. Representative Bell echoed Representative Armstrong's comments, and encouraged Committee members to review the Tennessee Promise program which, starting in 2015, will offer Tennessee high school graduates two years of tuition-free education at a community or technical college.

Representative McLean stated that Broadband is becoming an important issue which will be intensely discussed in the coming months and years. He added that the viewpoints of those who are on the ground and who understand what Broadband can bring to the table in a typical Arkansas school are important. He commented that the next presentation concerning the challenges and opportunities of a small school when it comes to implementing Broadband would be instructive.

Discussion of Broadband Implementation in a Small School District

#### Presenter:

Ms. Julie Johnson, Technology Coordinator, Cave City School District, was recognized. Ms. Johnson described Cave City School District as a small, rural district in northeastern Arkansas, which has a current enrollment of 1,275 students and a free and reduced rate of around 72%. She discussed the difficult process she had to go through to get additional bandwidth for the district following the introduction of the Bandwidth for Educational Enhancement (BEE) Initiative by the Department of Information Services (DIS) in 2010. She said, at that time, DIS was only able to increase the district's bandwidth from two (2) to four (4) T1 fiber optic lines, less than in most households. She stated follow-up requests for increased bandwidth were denied because of lack of access in the area; and, by 2012, the district had reached the point at which new devices would not connect to the network and teachers and students could not access the Internet. Ms. Johnson stated without the necessary bandwidth, the district would not be able to participate in online testing or utilize other online resources. She related that in July 2013, contracts for 100mg circuits at both campuses were signed; but said that's when the real nightmare began. She said in November 2013 the elementary and middle schools were successfully connected, but not the high school. Ms. Johnson went on to discuss additional difficulty with implementation; but said that in mid-January, the high school was successfully connected -- six months after contracts had been signed and ten and a half months after the provider had agreed to make the connection. Ms. Johnson described having continuing difficulties with the service provider, but also described the successful educational usages enabled by increased bandwidth. In conclusion, she commented that finally the students in Cave City have access to the same wealth of information as many of the other students in Arkansas. She said the process wasn't easy and wasn't without a fight. She urged legislators to find a way to make sufficient bandwidth possible for all students, no matter what their socio-economic status or their geographical location.

#### Presenter:

**The Honorable Charles Armstrong**, State Representative, District 30, was recognized. Representative Armstrong made remarks preliminary to a discussion by a group of presenters. He said this study was requested in 2013 for the purpose of putting all schools on the same level. Representative Armstrong expressed his hopes that the study will improve the system and encourage more parental involvement.

## Contributors to the Discussion:

**Dr. Gary Ritter**, Director, Office for Education Policy (OEP), University of Arkansas, was recognized. In a PowerPoint presentation, Dr. Ritter discussed components of a proposed "Best Practices" study plan prepared in response to the ISP study request. Dr. Ritter explained the two (2) components of the plan would entail a National "Best Practices" Literature Review and an Arkansas Specific Study. He also presented a projected study timeline. He stated that if the OEP conducts the actual study, additional/different items as proposed by the Arkansas Department of Education (ADE) and the State Board of Education (SBE) would be welcome and be folded into the study to fully and thoroughly answer questions that have been proposed.

**Mr. Adnan Ekin**, Superintendent, LISA Academy, was recognized. Mr. Ekin presented an overview of LISA Academy, and introduced speakers on best practices in several areas, including parental involvement, commitment to education and to engaging parents, academic preparation for college and future careers, and STEM festivals.

Discussion of Issues Related to Minimum Teacher Salaries

## Presenter:

**Ms. Nell Smith**, Administrator, Policy Analysis and Research Section, Bureau of Legislative Research, was recognized. Ms. Smith stated that at the end of the report presented at the June Adequacy Study meeting, which concerned additional costs the districts would incur if the statutory minimum teacher salary schedule was increased, the BLR was asked to provide follow-up information. She said the information pertained to how potential funding could be distributed to districts. She stated the issue was how to provide new funding to districts that would have to spend more money if the salary requirements were increased while at the same time not just enriching those districts whose salary schedules were well above the statutory minimum. Utilizing a PowerPoint presentation, Ms. Smith walked the Committees through the report, *Funding to Increase Teacher Salaries: Distribution Method Options*, discussing the current salary schedule and three (3) proposed options. She provided examples of the options, discussing features and variations on funding.
