18	TO REGULATE THE PROCUREMENT OF
19	CONSTRUCTION MANAGEMENT CONTRACTS BY
20	PUBLIC ENTITIES EXCEPT IN CERTAIN
21	CIRCUMSTANCES; AND TO REGULATE THE
22	PROCUREMENT OF CERTAIN CONTRACTS BY
23	PUBLIC ENTITIES.

26	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
27	
28	SECTION 1. Arkansas Code § 14-58-1001(a), concerning municipal
29	projects exceeding two million dollars, is amended to read as follows:
30	(a) <del>In the event</del> <u>If</u> funds from any sources for a municipal project
31	other than revenues derived from a performance-based efficiency project
32	exceed <del>two million dollars (\$2,000,000)</del> five million dollars (\$5,000,000),
33	excluding the cost of land, the provisions of this subchapter and all other
34	provisions of the Arkansas Code of 1987 Annotated governing construction of
35	public facilities, including <del>, but not limited to, the provisions of</del> without
36	<u>limitation</u> § 22-9-201 et seq., at the election of municipalities <del>shall not be</del>

1	applicable do not apply to the project if the selection and contracting
2	process set forth stated in this section is followed.
3	
4	SECTION 2. Arkansas Code § 14-58-1001(b), concerning municipal
5	projects exceeding two million dollars, is amended to add an additional
6	subdivision to read as follows:
7	(4) A contract for a project between a municipality and a
8	construction manager shall not be entered into without first obtaining review
9	by the Legislative Council or the Joint Budget Committee.
10	
11	SECTION 3. Arkansas Code § 14-58-1001(d), concerning municipal
12	projects exceeding two million dollars, is amended to add additional
13	subdivisions to read as follows:
14	(5)(A) The general contractor shall solicit sealed bids for all
15	divisions of a project from a list of approved subcontractors prepared by the
16	general contractor.
17	(B) The general contractor shall solicit a minimum of
18	three (3) bids for each division of the project.
19	(C) If the general contractor is unable to obtain a
20	minimum of three (3) bids for each division of the project, the general
21	contractor shall provide written documentation of its efforts and submit the
22	written documentation to the municipality for approval.
23	(D) If the general contractor desires to perform work in
24	any division of the project, the general contractor shall submit a sealed bid
25	in the same manner as a subcontractor.
26	(E) The municipality shall retain the right to approve or
27	disapprove the general contractor's list of subcontractors for the project
28	before the solicitation of sealed bids.
29	(6) The general contractor and a representative of the
30	municipality shall be present when the sealed bids are opened for each
31	division of the project.
32	(7)(A) The general contractor shall prepare and present a
33	tabulated form to the municipality that accurately represents the range of
34	bids for each division of the project.

1	(B) The tabulated form required under subdivision
2	(d)(7)(A) of this section is a public record under the Freedom of Information
3	Act of 1967, § 25-19-101 et seq., subject to any applicable exemptions.
4	(8) The construction contract for the project shall identify the
5	items that are included in the general conditions.
6	
7	SECTION 4. Arkansas Code § 19-4-1415(f), concerning projects exceeding
8	five million dollars, is amended to add additional subdivisions to read as
9	follows:
10	(5)(A) The general contractor for a project for an institution
11	of higher education shall solicit sealed bids for all divisions of a project
12	from a list of approved subcontractors prepared by the general contractor.
13	(B) The general contractor shall solicit a minimum of
14	three (3) bids for each division of the project.
15	(C) If the general contractor is unable to obtain a
16	minimum of three (3) bids for each division of the project, the general
17	contractor shall provide written documentation of its efforts and submit the
18	written documentation to the institution of higher education for approval.
19	(D) If the general contractor desires to perform work in
20	any division of the project, the general contractor shall submit a sealed bid
21	in the same manner as a subcontractor.
22	(E) The institution of higher education shall retain the
23	right to approve or disapprove the general contractor's list of
24	subcontractors for the project before the solicitation of sealed bids.
25	(6) The general contractor and a representative of the
26	institution of higher education shall be present when the sealed bids are
27	opened for each division of the project.
28	(7)(A) The general contractor shall prepare and present a
29	tabulated form to the institution of higher education that accurately
30	represents the range of bids for each division of the project.
31	(B) The tabulated form required under subdivision
32	(f)(7)(A) of this section is a public record under the Freedom of Information
33	Act of 1967, § 25-19-101 et seq., subject to any applicable exemptions.
34	(8) The construction contract for the project shall identify the
35	items that are included in the general conditions.

1 SECTION 5. Arkansas Code § 19-11-802(d), concerning restrictions on 2 competitive bidding for professional services contracts, is amended to add an 3 additional subdivision to read as follows: 4 (4) A contract between a public school district and a 5 construction manager for a project that exceeds five million dollars 6 (\$5,000,000), excluding the cost of land, shall not be entered into without 7 first obtaining review by the Legislative Council or the Joint Budget 8 Committee. 9 10 SECTION 6. Arkansas Code § 19-11-802, concerning restrictions on 11 competitive bidding for professional services contracts, is amended to add an 12 additional subsection to read as follows: 13 (e)(1)(A) The general contractor for a public school district project that exceeds five million dollars (\$5,000,000), excluding the cost of land, 14 15 shall solicit sealed bids for all divisions of a project from a list of 16 approved subcontractors prepared by the general contractor. 17 (B) The general contractor shall solicit a minimum of 18 three (3) bids for each division of the project. 19 (C) If the general contractor is unable to obtain a 20 minimum of three (3) bids for each division of the project, the general contractor shall provide written documentation of its efforts and submit the 21 22 written documentation to the state agency or political subdivision for 23 approval. 24 (D) If the general contractor desires to perform work in 25 any division of the project, the general contractor shall submit a sealed bid 26 in the same manner as a subcontractor. 27 (E) The state agency or political subdivision shall retain the right to approve or disapprove the general contractor's list of 28 29 subcontractors for the project before the solicitation of sealed bids. 30 (2) The general contractor and a representative of the state agency or political subdivision shall be present when the sealed bids are 31 32 opened for each division of the project. (3)(A) The general contractor shall prepare and present a 33 34 tabulated form to the state agency or political subdivision that accurately 35 represents the range of bids for each division of the project.

1	(B) The tabulated form required under subdivision
2	(e)(3)(A) of this section is a public record under the Freedom of Information
3	Act of 1967, § 25-19-101 et seq., subject to any applicable exemptions.
4	(4) The construction contract for the project shall identify the
5	items that are included in the general conditions.
