SENATE AND HOUSE COMMITTEES ON CITY, COUNTY, AND LOCAL AFFAIRS

Representative Lanny Fite called the meeting to order.

Approval of Minutes for the September 7, 2022, Meeting [Exhibit C]

Representative Warren made a motion to approve the minutes, seconded by Representative Dalby, without objection, the minutes were approved.

Review of Act 568 of 2021 – "An Act to create the small town economic development Act: To amend the exemptions to the licensing requirements for architects; and for other purposes." [Exhibit D]

Representative Pilkington provided an overview of Act 568 of 2021. Shana Bryant, Executive Director, Arkansas State Board of Architects, Landscape Architects, and Interior Designers (ASBALAID); Wesley Walls, AIA, President, ASBALAID; Daniel Parker, Chief Legal Counsel, Arkansas Department of Labor and Licensing (ADLL); Mark Whitmore, Chief Counsel, Association of Arkansas Counties; and John Wilkerson, General Counsel, Arkansas Municipal League; were recognized and discussed Act 568 of 2021.

Representative Dalby made a motion that the licensing requirements for architects and the exemptions for buildings where the total cumulative and fair market value exceeds a certain dollar amount should remain at \$250,000 and not revert to \$100,000. Representative Warren, seconded the motion without objection, the motion carried.

Considering for Adoption of Interim Study Proposal (ISP) 2021-133 by Senator Hammer – "Requesting the Legislative Council to refer to the Senate Committee on City, County, and Local Affairs request to study the creation of a state-level division dedicated to coordinating and providing assistance for local volunteer fire departments." [Exhibit E]

Representative Dalby made a motion to adopt ISP 2021-133, seconded by Representative Warren, and without objection, the motion carried.
