27	SECTION 1. Arkansas Code § 26-18-303(h), concerning allowable							
28	disclosures of tax records maintained by the Department of Finance and							
29	Administration, is amended to read as follows:							
30	(h)(1) Upon the request of a county government or a city government,							
31	the Secretary of the Department of Finance and Administration shall provide a							
32	report that includes a list of vendors within the requesting county or city							
33	who hold permits issued <del>pursuant to</del> <u>under</u> the Arkansas Gross Receipts Act of							
34	1941, § 26-52-101 et seq.							
35	(2) Requests made <del>pursuant to</del> <u>under</u> this subsection <del>must</del> <u>may be</u>							
36	made at any time and shall be <del>made in writing</del> submitted electronically by an							

1	official of the county government or city government <del>prior to August 1 of the</del>
2	calendar year for which the list is requested.
3	(3)(A) Lists provided pursuant to the provisions of this
4	subsection will be made available following October 1 of the year requested
5	and will be compiled from the list of all valid sales tax permit holders
6	within the requesting county or city as of September 1 of the year requested.
7	The Department of Finance and Administration shall prepare and deliver a
8	report under subdivision (h)(l) of this section that contains a list of
9	vendors, the tax identification number for each vendor, and the total amount
10	of taxes collected under the Arkansas Gross Receipts Act of 1941, § 26-52-101
11	et seq., by each vendor within the requesting county or city for the year.
12	(B) A report prepared under this subsection shall be
13	delivered electronically.
14	(4) <del>(A) A reasonable fee based upon the number of permit holders</del>
15	within the requesting city or county may be charged for the permit search
16	made and reported to the requesting county or city government.
17	(B) Fees collected under the provisions of this subsection
18	shall be deposited into the State Central Services Fund to be treated as a
19	refund of expenditures to reimburse the department for the costs of providing
20	the requested information. In order to receive a report under this
21	subsection, the city government or county government making the request shall
22	register for an account with the Arkansas Taxpayer Access Point, or its
23	successor portal.
24	(5) The Department of Finance and Administration shall not
25	discuss any details of a report prepared under this subsection with the city
26	government or county government making the request under this subsection or
27	with a third party.
28	(6) Information received by a city government or a county
29	government under this subsection shall remain confidential and is not subject
30	to disclosure except in accordance with this section.

32	SECTION 2. EFFECTIVE DATE. Section 1 of this act is effective on and
33	after January 1, 2022.
