Representative Tosh called the meeting to order.

Consideration to Approve the Minutes from the August 19, 2021; September 20, 2021; September 23, 2021; and September 27, 2021, Meetings [Exhibits C1-C4]

Discussion of Act 421 of 2021 [Exhibit D]

Representative Stephen Meeks, provided information on Act 421 of 2021 which created a study of the use of certain election technology. Ms. Leslie Bellamy, Director of Elections, Office of the Secretary of State; Mr. Michael Harry, Director of Legal, Office of the Secretary of State; and Mr. Daniel Shults, Director, State Board of Election Commissioners; discussed the capabilities of current election technology and possible concerns the public may have regarding Act 421.

Representative Tosh stated a report would be submitted for review as required by Act 421 without objection.

Discussion of Interim Study Proposal (ISP) 2021-096 [Exhibits E1-E3]

Representative Julie Mayberry; and Dr. Russell Jones, Dean, College of Business and Economic Development, Arkansas Tech University; presented research focused on the effectiveness and cost savings of using workfrom-anywhere strategies for state employees.

Discussion and Consideration for Adoption of ISP 2021-114 [Exhibit F]

Representative Justin Gonzales; Leslie Fisken, Chief of Legislative Affairs, Arkansas Department of Parks, Heritage, and Tourism; and Carlton Saffa, Chief Market Officer, Saracen Casino Resort; provided an update on efforts to change the name of the Toltec Mounds Archaeological State Park to the Plum Bayou Mounds Archaeological State Park.
