20	alcohol by the drink, the report of that police intervention is currently not
21	relayed to the Alcoholic Beverage Control Division or the Alcoholic Beverage
22	Control Enforcement Division; and

24	WHEREAS, these reports of police intervention are pertinent to the
25	duties of the Alcoholic Beverage Control Division and the Alcoholic Beverage
26	Control Enforcement Division and should be provided to each division as a
27	matter of due course,
