He further discussed Europe and China's various types of energy use in comparison to the United States and said that he would like to see a diverse balance of clean and renewable energy in Arkansas.

### **Update on Electric Cooperatives of Arkansas and Broadband/Fiber Efforts**

Doug Maglothin, Executive Director, Diamond State Networks reported on Diamond State Networks' cooperation with electric cooperatives in other states, their mission statement, challenges for rural telecom operators, cost, content peering, serving businesses in Arkansas, current Diamond State Networks deployment, and partnering with other states.

Discussion of Solar Initiatives, Broadband, and Rate Making Among the 17 Local Electric Cooperatives Buddy Hasten, CEO, Arkansas Electric Cooperative Cooperation and Arkansas Electric Cooperatives, Inc.; Doug Maglothin, Executive Director, Diamond State Networks; Derek Dyson, CEO, Today's Power Inc.; and Jude Lindholm, Rate Specialist, Arkansas Electric Cooperative Cooperation and Former Senior Research, Policy Analyst, Arkansas Public Service Commission, answered questions from Committee Members on energy efficiency audits, cyber security, solar panels, safety when using a combination of gas and electric in homes, security at power plants, rate increases, sizes of solar panels needed for businesses and residential use, and the length of usability of a coal fire plant.
