BASIS FOR YOUR COMPLAINT.

ON OR ABOUT 9:00 A.M. ON THURSDAY, APRIL 27, A ARKANSAS RESIDENT AUCTIONEERS LICENSES WAS ISSUED TO GAYLEN MCGEE OF LONOKE, ARKANSAS BY THE DIRECTOR OF THE ARKANSAS AUCTIONEERS LICENSE BOARD WITHOUT THE KNOWLEDGE OF THE BOARD CHAIRMAN OR IT'S MEMBERS.

THE LICENSE IN QUESTION WAS INACTIVE SINCE 2015 FOR A PERIOD OF SEVEN YEARS, WELL PAST THE PERIOD OF PAYING FOR RENEWAL AS STATED IN THE LAW.

THIS COMPLAINT IS NOT AGAINST THE CHAIRMAN OF THE BOARD NOR IT'S
MEMBERS BUT AGAINST MS. KELLI BLACK, THE DIRECTOR OF THE ARKANSAS
AUCTIONEERS LICENSE BOARD FOR ISSUING A LICENSE WITHOUT FOLLOWING
THE PROPER GUIDELINES SET FORTH IN THE LAW AND RULES AND
REGULATION.

WHEN ASKED IF MR. MCGEE FILLED OUT AN APPLICATION, MS. BLACK SAID NO. WHEN ASKED IF SHE RUN A BACKGROUND CHECK, SHE SAID NO, WHEN ASK IT HE WAS GIVEN A WRITTEN EXAM OR ORAL EXAM, THE ANSWER WAS NO. WHEN ASKED WHAT AUTHORITY SHE USED OR LAW THAT ALLOWED HER TO ISSUE THIS LICENSE SHE STATED R/R 10.3.

THE PROBLEM WITH 10.3 IS IT IS IN THE MIDDLE OF 10.2 AND 10.6 WHICH ALLOWS THE BOARD TO ISSUE A TEMPORARY RECIPROCAL LICENSE TO AN OUT OF STATE LICENSED AUCTIONEER WHO IS IN GOOD STANDING IN HIS/HER

HOME STATE. 10,3 WAS NEVER INTENDED TO BE USED TO ISSUE A
TEMPORARY LICENSE FOR A ARKANSAS RESIDENCE FOR THE PURPOSE OF
ACTING AS AN AUCTIONEER. IF IT HAD BEEN, WE WOULD HAVE PUT IT IN THE
SECTION FOR GETTING A LICENSE AND NOT IN THE SECTION ON RECIPROCITY.
THIS AUCTION TAKEN BY THE DIRECTOR HAS DELUDED THE MEANING OF
FOLLOWING THE LAW IN LICENSING.

FURTHERMORE, MS. BLACK STATED THAT SHE CHARGED MR. MCGEE \$200.00 TO ISSUE THE LICENSE AND THE LICENSE SHOWS HIS OLD NUMBER OF 1808. IN ALL OTHER CASES THE NEXT NUMBER AVAILABLE WOULD HAVE BEEN THE NEW NUMBER WHICH IS DIFFERENT FOR OTHERS RE-APPLYING FOR A AUCTIONEERS LICENSE. FOR THE SAME PERIOD FROM 2015 TO PRESENT A AUCTIONEER WHO RENEWED THEIR LICENSE ON TIME WOULD HAVE INVESTED APPROXIMATELY \$800.00 FOR THE LICENSE FEE AND SOME \$600.00 TO \$800.00 ATTENDING CE CLASSES AT CONVENTIONS OR ON LINE. IN ARKANSAS, YOU CANNOT RENEW YOUR LICENSE WITHOUT COMPLETING 6 HOURS OF CONTINUING EDUCATION IN THE LICENSING PERIOD UNLESS YOU ARE EXEMPT. THERE ARE SOME 850 LICENSED AUCTIONEERS THAT HAVE BEEN WRONGED BY THIS ACTION. IT IS A TOTALLY UNACCEPTABLE PRACTICE FOR A PROFESSIONAL ORGANIZATION. ATTACHED IS A AUCTIONZIP POST THAT IS ALSO MISLEADING.
