Discussion of the Arkansas Auctioneers Licensing Board [Exhibit D]

Neil Davis, Auctioneer, Neal Davis Auction & Realty Company, briefly discussed his complaint regarding Kelli Black, Director, Arkansas Auctioneers License Board, issuing Gaylen McGee an auctioneers license without the knowledge of the Arkansas Auctioneers License Board. Roy Ragland, Chief of Staff, Arkansas House of Representatives, discussed his experience when renewing his auctioneer's license after it had lapsed for several years.

Steven Guntharp, Chief of Staff, Department of Labor and Licensing; Kelli Black, Director, Auctioneers and Geology Licensing Boards; and Daniel Parker, Chief Legal Counsel, Department of Labor and Licensing; Ms. Black stated that the license that was issued to Mr. McGee was not a temporary license but a renewal of his original license. Mr. Parker cited Arkansas Supreme Court decision Chandler v Martin 2014 Ark. 219, as the basis for their decision to renew Mr. McGee's license.
