INTRODUCTION

Act 906 of the 2001 session of the Arkansas legislature requires the Arkansas Division of Children and Family Services (DCFS) to conduct an annual evaluation of family preservation services. The Act specifies several types of services, including those designed to prevent the removal of children from their homes, facilitate the reunification of families with children who have been removed from their homes, and help children attain safe and appropriate permanent living arrangements in the event that reunification does not occur.

These services encompass virtually all activities DCFS performs in its work with families and children. In this sense, any child or family that DCFS has assessed and/or the agency has opened a case for can be said to be in need of family preservation services. This report addresses whether the assistance and services that children and their families receive lead to positive results.

Within this context, the following report examines DCFS's performance during calendar year 2020 compared with its performance during the preceding two years. Many of the metrics analyzed herein replicate indicators currently monitored by the federal Children's Bureau, while other metrics are commonly used within Arkansas's and other states' child welfare systems. The report metrics are structured around safety, permanency, and well-being.

In addition to assessing statewide performance, this report examines individual service areas and counties' ability to keep children safe, help them gain permanency, and promote their well-being; their performance is detailed in the report as well.

SAFETY

REPORTS ACCEPTED FOR CHILD MALTREATMENT ASSESSMENT

During 2021, Arkansas accepted 27,617 child maltreatment reports for an investigation. The number of reports accepted for investigation increased by 8% from the previous year.

Of those investigations, 21,569 (78%) were assigned to DCFS; the remainder (n=6,048) were assigned to the Arkansas State Police Crimes Against Children Division.

DCFS was also responsible for all 4,393 reports that were accepted for differential response (DR) during the year. The number of DRs received increased by 18% from the previous year (Figure 1).

Of assessments (investigations and DRs combined) assigned to DCFS during 2021, 18% originated from Area 1 and nearly 13% originated from Area 8. DCFS staff from Area 10 received the fewest total assessments, followed by those in Areas 4 and 7 (Figure 2).

Accepted Child Maltreatment Reports Statewide




CHILD MALTREATMENT INVESTIGATIONS

TIMELINESS OF INITIATING INVESTIGATIONS

DCFS staff must see alleged victims within 24 hours of receipt of a priority one report and 72 hours of receipt of a priority two report. Agency staff statewide initiated 80% of their investigations on time during 2021 (Figure 3).

Area 9 had the highest rate (90%) of investigations initiated in a timely manner during the year, followed closely by Areas 2 and 10. For the third consecutive year, the lowest timely initiation rate was in Area 6 (59%), i.e., Pulaski County (Figure 4).

Among other individual counties, the struggle to initiate investigations on time in Garland (50%) and Saline (72%) counties negatively impacted Area 3's initiation rate, as did Union County (64%) in Area 4, and Jefferson County (59%) in Area 7. Appendix Table A1 displays, by county, the percentage of investigations with timely initiation.

Timely Investigation Initiation Statewide




TIMELINESS OF COMPLETING INVESTIGATIONS

Investigations are to be completed within 45 days of receipt of the report. In select instances, a 15-day extension may be granted, resulting in a 60-day completion requirement. DCFS completed 74% of its investigations on time in 2021, a decline from each of the past two years (Figure 5).

Areas 8, 9, and 10 had the highest timely completion rates (Figure 6). Though there were some exceptions (e.g., Greene County in Area 8, Crittenden and Jackson in Area 9), most counties within these areas completed over 90% of their investigations on time. Area 2, which performed well at *initiating* investigations on time, did less well with on-time completion.

Less than 60% of the investigations from each of Areas 3, 4, and 5 were completed on time. Many counties in these areas struggled to complete even half their investigations on time, including Garland and Perry counties in Area 3; Columbia, Lafayette, Nevada, Ouachita, and Union counties in Area 4; and Boone, Conway, Pope, Searcy, and Van Buren counties in Area 5.

Timely Investigation Completion Statewide




SUBSTANTIATION OF INVESTIGATIONS

Of all DCFS investigations during 2021, 24% were substantiated, a rate similar to the previous year's (Figure 7).

DCFS staff from Areas 10 (31%) and 4 (30%) had the highest rates of substantiated investigations, followed closely by Areas 5 and 2. For the third consecutive year, Areas 1 and 7 had the lowest substantiated rates (Figure 8).

Among individual counties, investigations were substantiated at the lowest rates in Benton and Washington (Area 1); Yell (Area 2); Saline (Area 3); Calhoun, Dallas, Grant, Lonoke, and Prairie (Area 7); Lawrence and Mississippi (Area 8); and Cleburne and White (Area 9). Meanwhile, over one-third of investigations were substantiated for the following counties: Scott (Area 2); Miller and Sevier (Area 4); Searcy (Area 5); Cleveland (Area 7); Izard (Area 8); Jackson, Poinsett, and Stone (Area 9); and Chicot, Phillips, and St. Francis (Area 10).

Statewide




PREVENTING MALTREATMENT RECURRENCE

Recurrence of maltreatment is measured by examining all victim children maltreated during a 12-month period and identifying how many were revictimized within the next 12 months. For example, for 2021, all child victims of maltreatment during 2020 were tracked to see whether they were victims of a subsequent maltreatment report within 12 months of the initial report.

Of victim children in Arkansas, 6% experienced a recurrence of maltreatment within 12 months of a substantiation for 2021. DCFS met the national standard with respect to the recurrence of maltreatment for each of the past three years (Figure 9). All 10 areas also achieved the national standard (Figure 10).

Of the 75 Arkansas counties, 61 met the standard; those that did not were Baxter, Boone, Carroll, Desha, Drew, Franklin, Lafayette, Logan, Madison, Perry, Polk, Pope, Sevier, and Van Buren counties. Aside from Pope, these counties are generally rural (i.e., sparsely populated).

Recurrence Within 12 Months Statewide




DIFFERENTIAL RESPONSE ASSESSMENTS

TIMELINESS OF INITIATING DR REFERRAL

DCFS must see all alleged victim children and at least one caregiver within 72 hours for DR referrals. Arkansas initiated 67% of DRs on time during 2021, a decline from each of the past two years (Figure 11).

While Areas 5 and 10 performed comparatively well, the lone area that truly excelled at initiating DRs on time was Area 8 (Figure 12). Outside of the counties comprising Area 8 where each of the nine counties initiated at least 95% of DRs on time—only a handful of counties performed well at on-time initiations. Specifically, over 90% of DRs were initiated on time in Columbia County (Area 4); Conway (Area 5); and Desha, Lee, and St. Francis counties (Area 10).

Area 2 struggled the most at initiating DRs on time, followed by Areas 9 and 3. Less than half of DRs were initiated on time in numerous counties throughout these areas, including Crawford, Franklin, Johnson, Logan, and Yell (Area 2); Perry and Saline (Area 3); and Cleburne, Crittenden, White, and Woodruff (Area 9).

Timely DR Referral Initiation Statewide



TIMELINESS OF COMPLETING DR REFERRALS

Reports assigned for DR must be closed within 30 days of receipt of the report. In certain instances when the families' needs necessitate longer involvement, up to two 15-day extensions can be granted, for a total of 60 days. DCFS completed 66% of DRs on time for 2021. This was a decrease from the previous two years (Figure 13).

As was the case with DR initiations, Area 8 stood alone as the only area where staff completed over 90% of DRs in a timely manner (Figure 14). Area 7 came next-closest (80%). Several counties in these areas generally performed well, including Craighead, Fulton, Izard, Lawrence, Mississippi, and Sharp in Area 8, and Cleveland, Grant, and Lonoke in Area 7.

For the second consecutive year, the lowest DR completion rates were observed in Areas 6 (40%) and 3 (44%). Four counties within Area 3—Howard, Montgomery, Pike, and Polk—each completed less than 15% of DRs on time during 2021.

Timely DR Referral Completion Statewide




IN-HOME PROTECTIVE SERVICES CASES

When a maltreatment report or court order necessitates DCFS involvement with a family but there is no immediate threat to any child's safety, the agency can provide in-home protective services to the family in which no children are removed from the home. DCFS was responsible for 2,506 open in-home cases at the end of 2021, which was similar to the number of open cases just one year before (Figure 15). Figure 16 displays the number of in-home cases by area.

The number of in-home cases decreased in six of the 10 areas since the end of 2020, with the largest declines occurring in Areas 1 (385 to 317) and 8 (281 to 232). The largest increase in in-home cases from 2020 to 2021 occurred in Areas 9 (205 to 257) and 5 (258 to 295).

Among counties, the largest net decreases in in-home cases occurred in Craighead (135 to 80) Washington (210 to 171), and Madison (24 to 9). The largest net increases in in-home cases occurred in Faulkner (70 to 108), Sebastian (122 to 141), Jackson (11 to 29), Poinsett (26 to 44), and Lonoke (25 to 41).

Open In-Home Protective Services Cases Statewide




DISCUSSION

STRENGTHS

Arkansas accepted 27,617 child maltreatment reports for investigation and another 4,393 for DR during 2021. The number of investigations increased by 8% and DRs increased by 18% from the previous year. In 2021, DCFS was responsible for 21,569 (78%) investigations and all DRs received.

DCFS successfully limited the recurrence of maltreatment within 12 months of a substantiated report, bettering the national standard (9.1% or less) for each of the last three years. All 10 areas met the standard for 2021, and the vast majority of individual counties did so as well.

AREAS FOR IMPROVEMENT

Improvement is necessary to ensure that the children and families cited in reports of maltreatment are seen more quickly. The rates at which DCFS initiates and completes both its investigations and DRs declined across the board during 2021. Agency staff initiated 80% and completed 74% of their investigations on time, and they initiated 67% and completed 66% of DRs on time.

While numerous areas struggled to initiate and complete investigations and DRs on time, those investigations and DRs originating from Areas 3 and 6 were especially challenging for DCFS staff.

PERMANENCY

CHILDREN IN FOSTER CARE

THE POPULATION

A total of 4,631 children were in foster care at the end of 2021, a slim decrease from one year prior (Figure 17). The number of children in foster care is approximately 12% lower than the all-time high of 5,234 that was reached during 2016 (not shown). Figure 18 displays children in care by area.

Area 1's foster child population plummeted during the year (581 to 479), with considerable decreases observed for both Benton (184 to 127) and Madison (64 to 35) counties. Area 2's foster child population also decreased (857 to 802), with the largest net decrease occurring in Sebastian County (556 to 487). More modest decreases occurred in Areas 4 (387 to 368), 9 (490 to 483), and 10 (165 to 135). The foster child population increased in the remaining five areas, with the largest net increase in Area 6 (621 to 678). Much of the increase in Area 3 (412 to 451) can be attributed to Clark (17 to 40) and Garland (177 to 205) counties, and the increase in Area 5 (401 to 460) can be largely attributed to Faulkner (115 to 149) and Pope (64 to 90) counties.

Children in Foster Care Statewide




PROXIMITY OF CHILDREN'S PLACEMENTS

Of children in care at the end of 2021, 69% were residing in a placement setting either within the same county from which they were removed or a neighboring county (Figure 19). This was similar to the previous two years.

Areas 1, 6, and 7 placed at least three quarters of children in close proximity to their homes, a higher rate than in the remaining seven areas (Figure 20).

At the other end of the spectrum, just half (50%) of the children from Area 10 were placed in close proximity to their homes. With the exception of Lee, Monroe, and Phillips counties—which actually performed quite well at placing children close to home—the counties in Area 10 struggled to place children close by.

Counties that drove performance within their areas include Benton (90%) in Area 1, Crawford (35%) and Sebastian (69%) in Area 2, Garland (75%) and Saline (88%) in Area 3, Miller (54%) in Area 4, Faulkner (70%) and Pope (71%) in Area 5, Jefferson (78%) and Lonoke (86%) in Area 7, Craighead (86%) and Greene (71%) in Area 8, and White (68%) in Area 9.

(Same or Neighboring County) Statewide




CHILD REMOVALS AFTER SUBSTANTIATION

DCFS staff removed 19% of the victim children in response to a true report (i.e., the children were removed from their home either during the investigation or within 10 days of its closure) in 2021, which was a slightly lower rate than in the previous two years (Figure 21).

For the second consecutive year, victim children from Area 10 (11%) were least likely to be removed in response to a true report. In all but one county in the Area, the removal rate was less than 16%.

The next-lowest removal rates were observed for Areas 2 and 8 (17% each). Crawford had the lowest removal rate (11%) in Area 2, and Craighead had the lowest (8%) in Area 8.

For the third consecutive year, the area where victim children were most likely to be removed in response to a true report was Area 4 (29%). This removal rate was driven by Sevier (42%), Little River (38%), and Columbia (31%) counties.

Child Removal After Substantiation Statewide




PERFORMANCE METRICS ON PERMANENCY

PLACEMENT WITH RELATIVES

Data show that children placed with relatives achieve better outcomes than those placed with non-relatives. As a result, DCFS has made a deliberate effort in recent years to use relatives as appropriate foster care placements. As of the end of 2021, 42% of children in care were in relative placements, higher than the rate observed for the previous two years (Figure 23). Six years ago (2015), the relative placement rate was less than 20% (not shown).

Seven of the 10 areas—Areas 2, 4, 5, 6, 7, 8, and 10—met the agency's goal of 40%, and Area 3 (39%) came very close (Figure 24). The best-performing county within each of these areas was Logan (Area 2), Clark (Area 3), Nevada (Area 4), Searcy (Area 5), Calhoun (Area 7), Clay (Area 8), and Lee (Area 10). Area 6's relative placement rate (40%) doubled from two years ago (20%).

Though its relative placement rate had improved from one year ago, Area 9 had the lowest relative placement rate for the second consecutive year (31%; Figure 24), Some counties within Area 9 did well at placing children with relatives (e.g., Cross at 47%); others were less successful (e.g., Crittenden at 19%).

Placement With Relatives Statewide




PLACEMENT STABILITY

Placement stability is measured by the rate of placement moves per 1,000 days in care for children who enter care over a 12-month period. The national standard is a rate of 4.12 or less.

For 2021, the placement stability rate was 5.25, lower than the rate observed for the past two years but still higher than the national standard (Figure 25). In 2015, the placement stability rate was 7.54 (not shown).

Children entering care from Area 7 reached, on average, greater placement stability than those from any other area, followed by those from Area 10 (Figure 26). Compared to the previous year, the placement rate decreased by approximately two moves, on average, for children entering care from Areas 6, 7, 8, and 10.

Children entering care from Areas 3 and 9 experienced the highest number of moves on average (Figure 26).

Overall, one third (25 out of 75) of Arkansas's 75 counties met the national standard for placement stability. Saline County (Area 3), Craighead County (Area 8), and Lonoke County (Area 7)—the sixth, seventh, and tenth most populous in the state—excelled at limiting children's moves.

Placement Stability Rate Statewide




REACHING PERMANENCY

Arkansas came very close to meeting the national standard of 40.5% or more for achieving permanency for children within 12 months of removal (Figure 27). Discharges from foster care due to reunification, relative custody, noncustodial parent custody, guardianship, adoption, and non-relative custody are considered to be permanent living situations.

Four of the 10 areas—Areas 1, 4, 8, and 9—met the national standard, while Areas 3 and 7 came close (Figure 28).

The state met the national standards of 43.6% for children in care for 12 to 23 months who reached permanency within the subsequent 12 months (57%) and the national standard of 30.3% for children in care for 24 months or longer who reached permanency within the ensuing 12 months (32%). Eight of the 10 areas (Areas 6 and 10 were the exceptions) met the standard for the 12- to 23-month interval. For the interval of 24 months or longer, eight of the 10 areas (Areas 4 and 7 were the exceptions) either met or came close to meeting the standard.

Statewide



PREVENTING FOSTER CARE REENTRY

Arkansas consistently meets the national standard (8.3% or less) for preventing child reentry into foster care within 12 months of discharge. For 2021, the statewide reentry rate was similar to the previous two years (Figure 29).

Seven of the 10 areas—Areas 1, 2, 3, 5, 7, 9, and 10—met the standard for limiting child reentry into care, and Area 4 came close to doing so. At the other end of the spectrum, a quarter (26%) of the children who had reunified in Area 6 subsequently reentered care within 12 months (Figure 30). Area 6 had met the standard in the previous two years.

After performing well at limiting reentries in 2020, Area 8 did less well in 2021. Area 8's struggles stemmed largely from Craighead (18%) and Greene (14%) counties.

Reentries Within 12 Months Statewide




TIME TO ADOPTION

Arkansas finalized adoptions for 788 children during 2021, which was higher than the number finalized during 2020 but not at the level seen in 2019 (Figure 31).

The average length of time from termination of parental rights (TPR) until adoption finalization was 11 months for 2021, nearly three months sooner than in 2020 and two months sooner than in 2019 (Figure 32). As a result, Arkansas bettered the national average of 12.1 months.

In seven areas, adoptions were finalized faster than the national average of 12.1 months; Area 4 took an average of six months to finalize adoptions, Areas 9 and 10 took an average of between seven and eight months, and Areas 3, 5, 7, and 8 took an average of between nine and 11 months.

Adoptions finalized in Areas 1, 2, and 6 took between 13 and 14 months, on average.
Adoptions in Washington
County (Area 1) took just over 15 months, while those in
Sebastian County (Area 2) took nearly 17 months.

Number of Finalized Adoptions Statewide




DISCUSSION

STRENGTHS

The number of children in foster care decreased slightly during 2021; and at the end of the year, 4,631 children were in care. DCFS generally performed well on most activities designed to preserve children's existing connections and expedite permanency.

Arkansas' research has shown that children placed with relatives have achieved better outcomes than those placed with non-relatives. As of the end of 2021, 42% of children in foster care were residing with relatives, which was five percentage points higher than one year prior and more than double that of six years prior (20%). The use of relative placements has positively affected Arkansas's placement stability rate, which decreased considerably over this same six-year timeframe—from 7.54 in 2015 to 5.25 in 2021.

DCFS did well at moving children in care toward permanency regardless of their length of time in care. For each of the past three years, the agency either met or very nearly met the federal standards with respect to achieving permanency within 12 months for (1) children who entered care during the year, (2) children in care for 12 to 23 months, and (3) children in care for 24 months or longer.

Arkansas also did well at moving children needing permanency toward adoption. For the 788 adoptions finalized during 2021, the average length of time from TPR to finalization was 11 months, three months sooner than the previous year and over a month sooner than the national average of 12.1 months.

DCFS likewise performed well at preventing children in foster care who reunify with their families from reentering care within 12 months. Arkansas met the national standard of 8.3% or less for the fourth consecutive year.

AREAS FOR IMPROVEMENT

Although DCFS has made considerable improvements in children's foster care placement stability in recent years, the rate still falls below the national standard. While the agency's focus on relative homes has proven to be successful thus far, the agency continues to explore strategies to increase its pool of non-relative foster homes that could serve as long-term placements for children who lack an appropriate relative caregiver.

A greater variety of placement options would also likely allow the agency to increase the number of foster children residing in a placement setting in close proximity to their homes, i.e., either within their removal county or a neighboring county. For each of the past three years, seven out of every 10 children in care were placed in close proximity to their homes.

WELL-BEING

ASSESSING AND VISITING CHILDREN AND FAMILIES

DCFS must assess children and families in in-home and foster care cases on an ongoing basis to identify their needs and provide appropriate services. DCFS's primary means of assessing and monitoring children and families is consistent face-to-face visits. Workers must visit each child in care in the placement setting once a month; for in-home protective services cases, workers must visit family members in their home at least once a month.

DCFS workers completed 76% of visits to in-home families during 2021, a rate similar to the previous two years but lower than DCFS's goal of 85% (Figure 33). In 2015, the in-home visitation rate was 56% (not shown).

Area 4 (86%) was the lone area to surpass DCFS's goal for 2021, though Areas 2 and 8 came close (Figure 34). Nearly all counties from these three areas completed over 80% of their required in-home visits.

The in-home visitation rate plummeted to 36% in Area 6, by far the lowest of all areas, and far below the Area's performance from just two years ago (79%). Areas 1 and 7 also struggled to complete their required in-home visits. The struggles were most evident in Washington County (47%) in Area 1 and Jefferson County (38%) in Area 7.

Statewide



VISITING CHILDREN IN FOSTER CARE

DCFS completed 77% of its required monthly visits to see foster children in their placement during 2021, which was eight percentage points lower than the visitation rate observed for each of the previous two years (Figure 35). Six years ago (2015), the foster child visitation rate was 73% (not shown).

Three areas—3, 4, and 10—came closest to meeting DCFS's goal of 95% for monthly visits to foster children during 2021, which was fewer than the previous year when eight areas met the goal of 85%. Area 6, which had made 86% of its visits just two years ago, fell to 54% (Figure 36).


Aside from Area 6 (i.e., Pulaski County), the lowest foster child visitation rates were in Areas 2 and 9. In particular, DCFS struggled to visit children from Sebastian County (67%) in Area 2 and White (58%) and Crittenden (64%) counties in Area 9.

Monthly Worker Visitation With Children in Foster Care



DISCUSSION

STRENGTHS

DCFS workers made more than three quarters of their required visits to see families with in-home cases and children in foster care during each of the past three years (i.e., 2019, 2020, 2021). DCFS performed well enough at completing visits to see children in foster care during 2019 and 2020 that it raised its foster child visitation goal from 85% to 95% for 2021.

AREAS FOR IMPROVEMENT

While DCFS has generally improved the frequency at which it monitors in-home cases, especially when compared to its performance from six years ago, efforts will need to become more consistent to reach the in-home visitation goal of 85%. Similarly, DCFS will need to make a more concerted effort to reach its newly established foster child visitation goal of 95%.

Progress is clearly desired in several pockets of the state (e.g., Area 1), but the most immediate need is in Area 6. Addressing the situation in Area 6 (i.e., Pulaski County), where—in any given month—just one out of every three in-home cases and just one out of every two children in foster care had received a face-to-face caseworker visit—would go a long way toward helping DCFS reach its visitation goals.
