Child Care & Early Childhood Education During COVID



Pre COVID/Current CC/ECE

Prior to March 2020

- 2,041 licensed/registered programs/ with capacity to serve 194,081
- 1,327 programs participating in Better Beginnings (AR Quality Rating and Improvement System)
- 18,651 children funded through federal child care assistance in FY 2019
- 168 infants/toddlers served through Early Head Start

Current Status

- 1,911 Licensed Programs/with capacity to serve 163,039
 - 20 programs permanently closed/capacity 1,147
 - Remaining programs are temporarily closed
- 1,371 programs participating in Better Beginnings
- 16,754 children funded through federal child care assistance year to date
- 168 infants/toddlers served through EHS



Support for CC/ECE

- Funding (federal Child Care Development Funding-\$41.4 m)
 - Funding to licensed programs who remained open during pandemic-\$2.9 M
 - Funding for licensed programs to meet pandemic requirements (thermometers, masks, cleaning supplies)-\$6.3M
 - Reimbursement for actual costs of deep cleaning/sanitization (COVID positive cases)-\$31,978.54
 - Supplemental funding for children who receive vouchers (\$10 for infants/toddlers, \$7 for preschool, \$5 for school age)-\$10.8 M
 - Child care assistance for essential workers (emergency responders, health care providers, pubic health personnel, child care/education, sanitation workers, manufacturing, food supply chain) without regard to income -\$4.4 M
 - Spent \$24.5 M as of 10/5/20



Pandemic Requirements

- Screen individuals prior to entry and outside if possible
 - The following criteria should be utilized to determine individuals that should not enter:
 - Current temperature of 100.4 degrees Fahrenheit or above or within the last 48 hours
 - Signs or symptoms of COVID-19 (fever, cough, shortness of breath, difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, loss of taste or smell
 - Had contact with someone confirmed with COVID-19 in the previous 14 days
- Limit group size to 10-including staff and children.
- Staff shall wear face masks to reduce risk of potential spread.



COVID Positive Cases in CC/ECE

- From March 2020-October 5, 2020, the following number of staff/children have tested positive in a licensed child care and early childhood education program (reported to DCCECE/ADH):
 - 273 children
 - 416 staff




Challenges

- Shift in funding model
- Some families are not taking children to child care/early childhood settings-remote work
- Approximately 400 providers that do not participate in any funding with DCCECE
- Program have reported difficulty in hiring staff





Child Care Centers Infant/Toddler Capacities




