INTRODUCTION

Act 906 of the 2001 session of the Arkansas legislature requires the Arkansas Division of Children and Family Services (DCFS) to conduct an annual evaluation of family preservation services. The Act specifies several types of services, including those designed to prevent the removal of children from their homes, facilitate the reunification of families with children who have been removed from their homes, and help children attain safe and appropriate permanent living arrangements in the event that reunification does not occur.

These services encompass virtually all activities performed by DCFS in its work with families and children. In this sense, any child or family that DCFS has assessed and/or for whom the agency has opened a case can be said to be in need of family preservation services. This report addresses whether the assistance and services that children and their families receive lead to positive results.

Within this context, the following report examines DCFS's performance during calendar year 2020 compared with its performance during the preceding two years. Many of the metrics analyzed herein replicate indicators currently monitored by the federal Children's Bureau, while other metrics are commonly used within Arkansas's and other states' child welfare systems. The report metrics are structured around safety, permanency, and well-being.

In addition to assessing statewide performance, this report examines individual service areas and counties' ability to keep children safe, help them gain permanency, and promote their well-being; their performance is detailed in the report as well.

SAFETY

REPORTS ACCEPTED FOR CHILD MALTREATMENT ASSESSMENT

During 2020, Arkansas accepted 25,554 child maltreatment reports for an investigation. The number of reports accepted for investigation declined by nearly 11% from the previous year.

Of those investigations, 19,987 (78%) were assigned to DCFS; the remainder (n=5,567) were assigned to the Arkansas State Police Crimes Against Children Division.

DCFS was also responsible for all 3,738 reports that were accepted for differential response (DR) during the year. The number of DRs received decreased by 30% from the previous year (Figure 1).

Of assessments (investigations and DRs combined) assigned to DCFS during 2020, 19% originated from Area 1. DCFS staff from Area 10 received the fewest total assessments, followed by those in Areas 4 and 7 (Figure 2).

Accepted Child Maltreatment Reports Statewide




CHILD MALTREATMENT INVESTIGATIONS

TIMELINESS OF INITIATING INVESTIGATIONS

DCFS staff must see alleged victims within 24 hours of receipt of a priority one report and 72 hours of receipt of a priority two report. Agency staff statewide initiated 86% of their investigations on time during 2020 (Figure 3).

Areas 2, 8, and 10 initiated at least 90% of their investigations in a timely manner during the year, followed closely by Areas 4 and 9. The lowest timely initiation rate was in Area 6 (75%), i.e., Pulaski County (Figure 4).

Among other individual counties, less than 80% of investigations were initiated on time in Washington County (Area 1); Garland, Perry, and Saline counties (Area 3), Nevada County (Area 4), Bradley, Calhoun, and Jefferson counties (Area 7), and Crittenden County (Area 9). Appendix Table A1 displays, by county, the percentage of investigations with timely initiation.

Timely Investigation Initiation Statewide




TIMELINESS OF COMPLETING INVESTIGATIONS

Investigations are to be completed within 45 days of receipt of the report. In select instances, a 15-day extension may be granted, resulting in a 60-day completion requirement. DCFS completed 86% of its investigations on time in 2020, an improvement over each of the past two years (Figure 5).

Areas 2, 8, 9, and 10 had the highest timely completion rates (Figure 6). Almost all counties within these areas completed over 90% of their investigations on time. Area 6, which struggled to initiate investigations on time, did well with on-time completion.

Area 5 (62%) struggled the most to complete their investigations on time; the lowest timely completion rates were in Faulkner (48%), Pope (42%), and Conway (52%) counties. Multiple counties in Areas 3 (Garland, Perry, Saline) and 4 (Columbia, Hempstead, Lafayette, Nevada, Ouachita, and Union) struggled to complete investigations as well.

Timely Investigation Completion Statewide




SUBSTANTIATION OF INVESTIGATIONS

Of all DCFS investigations during 2020, 25% were substantiated, higher than in previous years (Figure 7).

DCFS staff from Areas 2, 4, and 10 substantiated at least 30% of their assigned investigations during 2020. Areas 1 and 7 had the lowest substantiation rates (Figure 8).

Among individual counties, investigations were substantiated at the lowest rates in Benton (Area 1), Howard (Area 3), Calhoun and Lonoke (Area 7), Lawrence and Clay (Area 8), and White (Area 9) counties. Meanwhile, the following counties substantiated investigations at the highest rates: Madison (Area 1); Sebastian (Area 2); Little River, Miller, and Sevier (Area 4); Marion (Area 5); Greene (Area 8); Woodruff (Area 9); and Arkansas, Lee, and St. Francis (Area 10). Statewide




Area




PREVENTING MALTREATMENT RECURRENCE

Recurrence of maltreatment is measured by examining all child victims of maltreatment during a 12-month period and identifying how many were victimized within the next 12 months. For example, for 2020, all child victims of maltreatment during 2019 were tracked to see whether they were victims of a subsequent maltreatment report within 12 months of the initial report.

Just over 6% of child victims in Arkansas experienced a recurrence of maltreatment within 12 months of a substantiation for 2020. DCFS met the national standard with respect to the recurrence of maltreatment for each of the past three years (Figure 9). All 10 areas also achieved the national standard (Figure 10).


Of the 75 Arkansas counties, 59 met the standard; Ashley, Boone, Calhoun, Cleveland, Hot Spring, Izard, Jackson, Lafayette, Little River, Madison, Pike, Searcy, Sebastian, Sevier, Woodruff, and Yell counties did not. Aside from Sebastian, these counties are generally rural (i.e., sparsely populated). Appendix Table A4 displays the percentage of children who experienced maltreatment recurrence by county.

DIFFERENTIAL RESPONSE ASSESSMENTS

TIMELINESS OF INITIATING DR REFERRAL

DCFS must see all alleged victim children and at least one caregiver within 72 hours for DR referrals. Arkansas initiated 74% of DRs on time during 2020, an improvement over each of the past two years (Figure 11).

Areas 5, 8, and 10 performed comparatively well at initiating DRs (Figure 12). Those areas initiated over 85% of DRs on time, and most of the counties within likewise did well.

Outside of these areas, only a handful of counties achieved a timely initiation rate of at least 90%: Benton (Area 1); Polk (Area 3); Ouachita (Area 4); Poinsett (Area 9); and Arkansas, Drew, and Monroe counties (Area 10).

Areas 3, 6, and 7 struggled to initiate DRs on time. For several counties throughout Areas 3 and 7, less than half of DRs were initiated on time, highlighted by Montgomery (47%), Perry (44%), Pike (47%), and Saline (47%) counties in Area 3 and Bradley (42%), Calhoun (0%), Cleveland (14%), Dallas (29%), Jefferson (39%), and Lincoln (31%) counties in Area 7.

Timely DR Referral Initiation Statewide




TIMELINESS OF COMPLETING DR REFERRALS

Reports assigned for DR must be closed within 30 days of receipt of the report. In certain instances when the families' needs necessitate longer involvement, up to two 15-day extensions can be granted, for a total of 60 days. DCFS completed 77% of DRs on time for 2020. This was a decrease from the previous two years (Figure 13).

Areas 5 and 8 each completed over 90% of DRs in a timely manner, and Areas 2, 4, and 7 completed over 85% on time (Figure 14). Aside from a few exceptions (e.g., Crawford in Area 2, Jefferson in Area 7), the counties in these areas generally performed well.

The lowest DR completion rates were in Areas 3 (40%) and 6 (50%). Performance in these areas declined steeply from just two years ago (94% for Area 3 and 89% for Area 6). For the second consecutive year, the completion rate declined for both areas, including each county within Area 3.

Timely DR Referral Completion Statewide




IN-HOME PROTECTIVE SERVICES CASES

When a maltreatment report or court order necessitates DCFS involvement with a family but there is no immediate threat to any child's safety, the agency can provide in-home protective services to the family in which no children are removed from the home. DCFS was responsible for 2,489 open in-home cases at the end of 2020, an increase of 29% from 2018 (Figure 15). Figure 16 displays the number of in-home cases by area.

The number of in-home cases increased in nine of the 10 areas from 2018, with the largest jump occurring in Area 6, where the number of cases more than doubled (191 to 419). The nextlargest increases occurred in Areas 4 (55%), 1 (38%), and 2 (32%). The only decrease in inhome cases occurred in Area 9. Among counties, the largest net increases in in-home cases occurred in Washington (142 to 210), Craighead (99 to 135), Benton (98 to 132), and Sebastian (91 to 122) counties; the largest decreases occurred in Phillips (30 to 14) and Lonoke (36 to 25) counties.

Open In-Home Protective Services Cases Statewide




DISCUSSION

STRENGTHS

Arkansas accepted 25,554 child maltreatment reports for investigation and another 3,738 for DR during 2020; these figures were well below the number of investigations and DRs received during the previous year. For 2020, DCFS was responsible for 19,987 (78%) investigations and all DRs received.

The rate at which DCFS initiated and completed its investigations improved in 2020; the agency both initiated and completed 86% of investigations on time during the year. Areas 2, 8, and 10 performed especially well, exceeding 90% compliance for each of these tasks. DCFS staff also improved the rate at which they initiate DRs on time, increasing from 63% in 2018 to 74% for 2020.

DCFS successfully limited maltreatment recurrence within 12 months, bettering the national standard (9.1% or less) for each of the last three years. All 10 areas met the standard for 2020.

AREAS FOR IMPROVEMENT

While DCFS continued to make progress regarding the timely initiation of DRs during 2020, additional improvement is necessary to ensure that these families are seen more quickly. In particular, Areas 3, 6, and 7 had trouble initiating DRs on time.

Additionally, timely DR completion has regressed from 86% two years ago to 77% for 2020. DRs originating from Areas 3 and 6 were especially problematic for agency staff.

PERMANENCY

CHILDREN IN FOSTER CARE

THE POPULATION

There were 4,651 children in foster care at the end of 2020, an increase of 10% over the previous year (Figure 17). Prior to 2020, the number of children in foster care had steadily declined since reaching an all-time high (5,234) during 2016 (not shown) until the end of 2019. Figure 18 shows children in care by area at the end of 2020.

Much of the foster child increase during the year can be attributed to Areas 6 (386 to 621) and 4 (280 to 387), with more modest increases occurring in Areas 3, 5, and 7. Excluding Area 6 (i.e., Pulaski County), the largest net increases within these areas occurred in Garland County (152 to 177) in Area 3, Hempstead (23 to 44) and Miller (90 to 131) counties in Area 4, Boone County (40 to 71) in Area 5, and Jefferson County (86 to 119) in Area 7.


The foster child populations decreased in Areas 8, 9, and 10. With the exception of Greene (Area 8) and White (Area 9) counties, the foster child population either decreased or effectively stayed the same for the counties in those areas.

PROXIMITY OF CHILDREN'S PLACEMENTS

Of children in care at the end of 2020, 73% were residing in a placement setting either within the same county from which they were removed or a neighboring county (Figure 19). This was similar to the previous year and a considerable improvement from five years ago at 62% (not shown).

Areas 1 (85%) and 6 (84%) placed the highest percentage of children in close proximity to their homes (Figure 20).

Within Area 1, over 95% of the children from Benton County were placed in close proximity, while just 59% of children in care from Area 10 were placed in close proximity to their homes. All Area 10 counties except Monroe placed less than two thirds of children close by. The percentage of nearby child placements ranged from 67-74% for the other seven areas. Noteworthy counties include Crawford (33%) and Sebastian (68%) in Area 2, Garland (77%) and Saline (87%) in Area 3, Miller (68%) in Area 4, Faulkner (66%) and Pope (71%) in Area 5, Jefferson (79%) and Lonoke (78%) in Area 7, Craighead (83%) and Greene (70%) in Area 8, and Crittenden (85%) and White (81%) in Area 9.

Proximity of Child's Placement (Same or Neighboring County) Statewide




CHILD REMOVALS AFTER SUBSTANTIATION

DCFS staff removed 21% of the victim children in response to a true report (i.e., the children were removed from their home either during the investigation or within 10 days of its closure) in 2020, similar to the removal rates for the previous two years (Figure 21).

For the second consecutive year, victim children from Area 4 were more likely to be removed in response to a true report (33%) than those from any other area. Area 4's removal rate was driven by Sevier (53%), Little River (42%), Lafayette, (42%), and Miller (37%) counties.

Area 6—where the removal rate was 16% for 2018 and 20% for 2019—surged to 25% for 2020. Area 7's rate was also comparatively high and clearly impacted by Bradley (56%), Grant (52%), and Jefferson (26%) counties.

Area 10 (9%) was least likely to remove children in response to a true report. Within Area 10, children from Desha (16%) and Phillips (14%) had the highest removal rates; the remaining seven counties had a removal rate of less than 10%.

Child Removal After Substantiation Statewide




PERFORMANCE METRICS ON PERMANENCY

PLACEMENT WITH RELATIVES

Data show that children placed with relatives achieve better outcomes than those placed with nonrelatives. As a result, DCFS has made a deliberate effort in recent years to use relatives as appropriate foster care placements. As of the end of 2020, 37% of children in care were in relative placements, higher than the rate observed for the previous two years (Figure 23). Five years ago (2015), the relative placement rate was just under 20% (not shown).

Eight of the 10 areas—Areas 1, 2, 3, 4, 5, 7, 8, and 10—met the agency's goal of 33%, and Area 6 (32%) came very close (Figure 24). The best-performing counties within these areas were Benton (Area 1), Yell (Area 2), Montgomery and Perry (Area 3), Columbia (Area 4), Conway and Faulkner (Area 5), Cleveland and Prairie (Area 7), Fulton and Sharp (Area 8), and Arkansas and Lee (Area 10).

Area 9 had the lowest relative placement rate (27%; Figure 24). While some counties within Area 9 did well at placing children with relatives (e.g., Cleburne at 56%), others were less successful (e.g., White County at 16%).

Placement With Relatives Statewide




PLACEMENT STABILITY

Placement stability is measured by the rate of placement moves per 1,000 days in care for children who enter care over a 12-month period. The national standard is a rate of 4.12 or less.

For 2020, the placement stability rate was 5.64, lower than the rate observed for the past two years but still higher than the national standard (Figure 25). In 2015, the placement stability rate was 7.54 (not shown).

Children entering care from Areas 2 and 5 reached greater placement stability than those from any other area. The placement rate was less than 4.00 for several counties there (Franklin and Logan counties in Area 2; Baxter, Conway, Newton, and Searcy counties in Area 5).

Children entering care from Areas 6 and 8 experienced the highest number of moves on average (Figure 26). Within Area 8, the highest rates were in Greene, Randolph, and Craighead counties.

Overall, 26 of Arkansas's 75 counties met the national standard for placement stability, compared with 18 counties in 2019. Saline County (Area 3) and White County (Area 9), the sixth and ninth most populous in the state, excelled at limiting children's moves.

Placement Stability Rate Statewide




REACHING PERMANENCY

Arkansas consistently exceeds the national standard of 40.5% or more for achieving permanency for children within 12 months of removal (Figure 27). Discharges from foster care due to reunification, relative custody, noncustodial parent custody, guardianship, adoption, and nonrelative custody are considered to be permanent living situations.

Eight areas met the national standard, with only Areas 2 and 6 falling short (Figure 28).

The state also exceeded the national standards of 43.6% for children in care for 12 to 23 months who reached permanency within the subsequent 12 months (59%) and the national standard of 30.3% for children in care for 24 months or longer who reached permanency within the ensuing 12 months (35%). All areas met the standard for the 12- to 23-month interval. For the interval of 24 months or longer, most areas either met or came close to meeting the standard (the only area to fall well short was Area 7).

Appendix Tables A13–A15 display the state's performance with respect to achieving permanency for these three intervals by county.

Statewide




PREVENTING FOSTER CARE REENTRY

Arkansas consistently meets the national standard (8.3% or less) for preventing child reentry into foster care within 12 months of discharge. For 2020, the statewide reentry rate improved (i.e., decreased) slightly compared with the previous two years (Figure 29).

Seven of the 10 areas—Areas 1, 2, 4, 6, 8, 9, and 10—met the standard for limiting child reentry into care, and Area 3 came close to doing so. At the other end of the spectrum, 20% of the children who reunified in Area 7 subsequently reentered care within 12 months (Figure 30). Area 7's struggles with limiting reentries stemmed largely from Jefferson (29%) and Lonoke (21%) counties.

Reentries Within 12 Months Statewide



TIME TO ADOPTION

Arkansas finalized adoptions for 713 children in 2020, far lower than in each of the previous two years (Figure 31).

The average length of time from termination of parental rights (TPR) until adoption finalization was 13.9 months for 2020, nearly one month longer than in 2019 and three months longer than in 2018 (Figure 32).

In four areas, adoptions were finalized faster than the national average of 11.8 months; Areas 3, 7, and 9, took an average of eight to nine months to finalize adoptions, while Area 10 took 10 months. Adoptions finalized in Area 2 took the longest (19 months on average); Crawford and Sebastian counties accounted for 70% of the Area's adoptions and took 19 and 21 months, respectively. Adoptions finalized in Areas 1 and 6 (16 months each) took a long time as well. Appendix Table A17 displays the number of finalized adoptions and the average time from TPR to adoption finalization by county.

Number of Finalized Adoptions Statewide




DISCUSSION

STRENGTHS

Although the number of children in foster care increased by 10% during 2020—from 4,226 to 4,651 children—DCFS generally succeeded or performed well on many activities designed to preserve children's existing connections and expedite permanency.

Arkansas has continued to prioritize relative foster care placements: 37% of children in foster care at the end of 2020 were residing with relatives, four percentage points higher than one year ago and nearly double that of five years ago (20%). For 2021, Arkansas has increased its relative placement goal from 33% to 40%. The focus on relative placements has positively impacted Arkansas's placement stability rate, which decreased considerably over this same period (7.54 in 2015 down to 5.64 for 2020).

The increased use of relatives also has likely contributed to the parallel increase in foster children residing in a placement setting either within the removal county or a neighboring county during this five-year period; 73% of children were placed in a home or neighboring county at the end of 2020, up from 62% for 2015.

DCFS performed well at moving children in care toward permanency regardless of their length of time in care. For each of the past three years, the agency met the federal standards with respect to achieving permanency within 12 months for (1) children who entered care during the year, (2) children in care for 12 to 23 months, and (3) children in care for 24 months or longer.

DCFS likewise did well at preventing children in foster care who reunify with their families from reentering care within 12 months. Arkansas met the national standard of 8.3% or less for the third consecutive year.

AREAS FOR IMPROVEMENT

Although DCFS has made considerable improvements in children's foster care placement stability in recent years, the rate still falls well below the national standard. While none of the 10 areas met the standard for 2020, Areas 2 and 5 nearly did. Conversely, the highest rates of placement moves were in Areas 6 and 8.

The average length of time from TPR to adoption finalization was nearly 14 months for the 713 adoptions finalized during 2020, longer than in each of the previous two years. As a result, Arkansas's performance on this item for 2020 lagged two months behind the national average of 11.8 months.

WELL-BEING

ASSESSING AND VISITING CHILDREN AND FAMILIES

DCFS must assess children and families in in-home and foster care cases on an ongoing basis to identify their needs and provide appropriate services. DCFS's primary means of assessing and monitoring children and families is consistent face-to-face visits. Workers must visit each child in care in the placement setting once a month; for in-home protective services cases, workers must visit family members in their home at least once a month.

DCFS workers completed 77% of visits to in-home families during 2020, an increase of four percentage points from 2018 (73%) and closer to DCFS's goal of 85% (Figure 33). In 2015, the in-home visitation rate was 56% (not shown).

The in-home visitation rate has improved in nine of the 10 areas since 2018, with the sharpest increase in Area 2 (62% to 90%; not shown). For 2020, Areas 2, 4, and 9 met DCFS's goal and Areas 5, 8, and 10 came close (Figure 34).

In Area 6, the visitation rate has decreased over the past two years from 82% to 56%. Despite improved performances within Areas 1 and 3, several counties struggled to make their required in-home visits (Washington County in Area 1 and Clark, Garland, and Saline counties in Area 3). Appendix Table A18 displays the agency's performance at visiting in-home families by county.

Statewide



VISITING CHILDREN IN FOSTER CARE

DCFS completed 85% of its required monthly visits to see foster children in their placement during 2020, similar to 2019 and slightly higher than 2018 (Figure 35). Five years ago (2015), the foster child visitation rate was 73%.

As was the case with in-home visits, all areas except Area 6 improved the rate at which workers visited children in foster care from the previous year. As a result, eight areas—Areas 2, 3, 4, 5, 7, 8, 9, and 10—met DCFS's goal of 85% for monthly visits to foster children during 2020 (Figure 36). Area 6 met this goal for 2018 and 2019 before falling to 65% in 2020.

Aside from Area 6 (i.e., Pulaski County), the foster child visitation rate only fell below 75% for 2020 in Mississippi County (57%) in Area 8.

Statewide




DISCUSSION

STRENGTHS

DCFS workers have consistently improved their rate of in-person visits to children in foster care and families with in-home cases in recent years. Agency workers made just 56% of required monthly visits to in-home families in 2015, but by 2020, the rate had increased to 77%. Agency staff made 73% of their required monthly visits to children in foster care in 2015, but compliance reached 85% for 2019 and for 2020. As a result, the agency met its goal of 85% for the past two years. DCFS has increased its foster child visitation goal from 85% to 95% for 2021.

AREAS FOR IMPROVEMENT

While DCFS has steadily improved the frequency at which it monitors in-home cases, there is more work to do to reach the in-home visitation goal of 85%. The lowest in-home visitation rates for 2020 were in Areas 1, 3, and 6.
